<b>JUDGES AND JUDGES' PANELS</b>	<p>Competitions will be evaluated by two Judges' Panels as follows:</p> <ul style="list-style-type: none"> <li>• 4 Difficulty (D) Judges (min. cat. 2)</li> <li>• 6 Execution (E) Judges (min. cat. 3)</li> <li>• 2 Line (L) and 1 Time (T) Judges (min. cat. 4)</li> </ul> <p>Priority will be given to the highest categories.</p> <p>The Judges' Panels are set up by a draw from the judges present at the event. The draw will be directed by the RG Technical Delegate.</p> <p>The participating member federations must send one qualified judge if they participate with individual gymnasts and one qualified judge if they participate with a group. Those judges can be the same or different.</p> <p>The Organizing Member Federation is responsible that there are enough FIG brevetted judges present with the appropriate valid category of brevet for their function. Should there not be sufficient judges as per the online nominative registration, or not sufficient cat. 1 and 2 judges, the Organizing Member Federation must propose to the FIG for prior approval of the Technical Delegate the name of neutral additional judges to complete the panels (plus 2 reserves). These judges, once approved, have to be invited at the cost of the Organizing Member Federation.</p> <p>Such invitation must be made through the respective Member Federation. Should the Organizing Member Federation fail to propose names for additional judges, the FIG Office in consultation with the Technical Delegate concerned will invite these judges at the cost of the Organizing Member Federation.</p> <p>The Organizing Member Federation will apply a fine of CHF 2'000 per missing judge to be paid to the LOC at accreditation should a federation fail to bring the required number of judges or judges without the requested qualification (brevet).</p> <p><b>Note:</b> Judges are allowed to watch the Podium training session from the delegation seating only.</p>

## TIE BREAKING RULES

In case of a tie at any place, the tie breaking rules for the RG World Championships as outlined in the current FIG Technical Regulation Section 3 shall be applied.

After application, if there is still a tie:

For participation to the Apparatus Final (Individual) and Final Routine (Group):

- The tied gymnasts / groups will proceed to the final.

For Prize money:

- The prize money of the tied ranks will be added and divided by the number of ties.

For World Challenge Cup Points:

- The World Challenge Cup points of the tied ranks will be added and divided by the number of ties.

For Yearly winner (Rules for the RG FIG World Challenge Cup Series 2017, 2018, 2018, 2020):

- Should there be a tie, the number of ranks of the three counting competitions achieved by the respective gymnast/group will be added and the gymnast/group with the lowest total will prevail.
- If there is still a tie, the total score of the three counting exercises will be added and the gymnast/group with the highest total will prevail.
- If there is still a tie, the total execution score of the three counting exercises will be added and the gymnast/group with the highest total execution score will prevail.
