JUDGES AND JURIES	<p><b>All Judges must have a current valid FIG Brevet at the time of the event for the respective discipline.</b> Minimum Category 3 required. Any Category 4 judge presented by participating delegations can only be used as Time and Line Judges.</p> <p>1. MAG and WAG All-Around Qualification (Olympic Qualifier): Minimum 1 Supervisor, 2 D panel and 4 E Panel on each apparatus, with additional line and time judges.</p>

ACCREDITATION	<p>Members of participating delegations as well as FIG, UAG representatives, judges and officials must send electronic ID photographs to the OC via email within the deadline set for the nominative registration of 24 April 2021.</p> <p>Gymnasts names / ages / nationality will be verified with a passport check at Accreditation. The LOC will check the validity of the gymnast's licenses. No gymnast will be accepted without a valid FIG license at the time of the deadline of the Nominative registration (valid until the end of the competition).</p>																	
EVENT FORMAT	<p><u>All-Around event based on Qualifications results:</u></p> <p>The All-Around consists of the following:</p> <ol style="list-style-type: none"><li>1. The All-Around Result will form part of the Olympic Qualifying Event</li><li>2. There will be no awards.</li><li>3. There will only be one vault required to be competed.</li><li>4. In case of a tie at any place (i.e. for gymnasts with the same final score), the tie will be broken according to the FIG Technical Regulations.</li></ol>

MEDICAL SERVICES	<p>Emergency medical team with ambulance will be on site at the competition and training venue.</p> <p>The anti-doping controls may take place at any time. The doping controls will be organized according to the current WADA Code, WADA International Standards and FIG Anti-Doping Rules.</p>																	
COVID 19	<p>Besides the medical guidelines for the particular event, FIG also requires all the participants to follow the standard precautions. The FIG Medical Guidelines During COVID-19 Pandemic should be respected by the participants. The FIG requires all participants, judges and officials to take standard precautionary measures, such as frequent hand-washing, wearing masks or face coverings at all times and keeping a physical distance of at least 1.5 metres whenever possible.</p> <p>The only situation in which the safety distance does not have to be respected is when a coach provides assistance (catch, lead, spotting) during an athlete's performance. This phase must be kept as short as possible and the assisting person is obliged to wear a mask throughout.</p> <p>Gymnasts do not need to wear a mask or face covering while they are performing at the training venue or on the FOP and keeping a physical distance of at least 1.5 metres whenever possible.</p> <p><b>A medical Guide specific for the event will be distributed one month before the event regarding to standard changes by health authorities in Egypt at the time of the event</b></p>																	
VISA	<p>Please verify with your travel agent or the <b>Egyptian</b> Embassy or Consulate in your country if a visa is required for your travel to Egypt. The Organizing Committee will be happy to assist each Delegation member with an official</p>																	

	<p>invitation letter, provided that the request is made before <b>24 of April 2021</b> to the LOC.</p> <p>The request must include the function, full name, gender, date of birth, citizenship and passport number, passport expiry date, the arrival and departure dates of the Delegation Member as well as the city the visa application support letter must be sent to.</p>
<b>INSURANCE</b>	<p>The Host Federation, the LOC, the UAG and the FIG will not be held responsible for any liabilities in case of accidents, illness, repatriation, Covid19 quarantine and the like.</p> <p>The FIG Technical Regulations foresee that all participating Federations are responsible for making their own arrangements to have the necessary valid insurance coverage against illness, accidents, Covid19 and for repatriation for all the members of their Delegation.</p> <p>Proof of the Insurance Policy, listing the Gymnasts and Officials by names with Date of birth and Passport Numbers must be handed in during the formal accreditation. The insurance must be in English.</p> <p>The LOC will verify the insurance upon arrival of the delegation members (e.g. cover note or photocopy of the valid policy). Delegation members with insufficient insurance coverage must inform the LOC in advance. The LOC cannot be held responsible if insufficient insurance cover is declared. Federations will be responsible for any costs incurred due to lack of adequate insurance.</p> <p><b>The LOC can offer and arrange insurance for a Federation that has not complied with insurance cover per person for the duration of the event - the cost will be payable, immediately on site by the Federation. No gymnast will be permitted to compete without adequate approved insurance.</b></p>
<b>INTERNATIONAL TRANSPORTATION</b>	<p>The invited participating federations are responsible for the travel costs and visa fees of their delegation members. The Travel Schedule Form must be returned to the LOC by <b>1 MAY 2021</b>.</p> <p><b><u>CURRENT ADDITIONAL REQUIREMENTS WHEN TRAVELING TO EGYPT UNDER COVID19 REGULATIONS</u></b></p> <p>Requirements to enter Egypt :</p> <ul style="list-style-type: none"> <li>• Eligible travelers must present a paper copy of a negative PCR test result for COVID-19 (in English, Arabic or French) that is <b>less than 72 hours before departing for Egypt</b></li> <li>• Passengers with any symptoms of Covid-19 or whose temperature 38 ° C or above may be refused boarding</li> <li>• Passengers travelling to Egypt may be refused entry if they have not completed a Covid-19 Public Health Declaration Form at <a href="https://egypt.mfa.gov.eg/storage/app/sites/26/declaration-form.pdf">https://egypt.mfa.gov.eg/storage/app/sites/26/declaration-form.pdf</a> before departure. Passengers must hold a hard copy of the completed Health Declaration Form.</li> </ul> <p><b>Due to the current situation related to the COVID-19 pandemic, the FIG, UAG and the EGY National Federation are constantly in contact and more information will be given closer to the event.</b></p>
