All NOCs are required to provide 1 CD of the music for each gymnast into the SID on **2 August 2021**, at 21:00h at the very latest in the highest quality format available, in accordance with the Team Leaders Manual. Recordings must be labelled as follows: "Nation\_discipline\_apparatus\_LAST NAME\_Given name". Media supports containing music in CD, in line with the instructions provided in the Team Leaders Guide, should include on the covers, discs or inserted reference, the exact running time of the music (not the performing time), which will be certified by the competitor and team leaders.


