Host country Estonia may register 4 individual gymnasts.</li> <li>3) Medal winners of the <b>All-Around Competition</b> of the Olympic Games, the last World Championships or the last European Championships have the right to participate additionally</li> <li>4) 1 individual gymnast per Federation (the best National gymnast) + 1 coach + 1 judge</li> </ol> <p><b>The LOC will cover accommodation, meals and local transportation for the following participants:</b></p> <ol style="list-style-type: none"> <li>1) 2022 Grand Prix Organizers (EST, RUS, UKR, FRA, ISR, CZE, ESP) 2 individual gymnasts, 1 coach, 1 judge</li> <li>2) Medal winners in All-Around Competition of the latest Olympic Games, World Championships and European Championships (All-Around gold-silver-bronze)</li> <li>3) Top-12 gymnasts of each apparatus final after the last 2022 Grand Prix in Moscow (RGI) (nominative invitations)</li> </ol>

<b>MEDICAL SERVICES</b>	<p>The Local Organizing Committee will provide a first medical aid service, a doctor and emergency medical transportation in the competition area.</p>
<b>COVID 19</b>	<p>Besides the FIG medical guidelines for the particular event, FIG also requires all the participants to follow the standard precautions.</p> <p>The FIG requires all participants, judges and officials to take standard precautionary measures, such as frequent handwashing, wearing masks at all times and keeping a physical distance of at least 1.5 metres whenever possible.</p> <p>The only situation in which the safety distance does not have to be respected is when a coach provides assistance (catch, lead, spotting) during an athlete's performance. <b>INSURANCE</b>	<p>The Host Federation, the LOC and the FIG will not be held responsible for any liabilities in case of accidents, illness repatriation and the like.</p> <p>The FIG Technical Regulations foresee that all participating Federations are responsible for making their own arrangements to have the necessary valid insurance coverage against illness, accidents and repatriation for all the members of their Delegation.</p> <p>Basic insurance (sickness, accident and repatriation) in your country of residence is compulsory in order to be able to benefit from coverage by FIG IMSSA subsidiary insurance.
