Make sure that your gymnasts use only FIG certified Hand Apparatus for this event and for any other FIG recognized competitions, as they will not be allowed to compete with an Apparatus which does not comply with the norms. MEDICAL SERVICES	<p>The Organizing Committee will provide a first aid medical service. Conditions for entering Serbia concerning Covid-19 can be found on the official site of our Ministry of foreign affairs: https://www.mfa.gov.rs/en/citizens/travel-serbia/covid-19-entry-requirements?lang=lat</p> <p>For all those who will need a PCR test or Antigen Rapid test for going back home, LOC will organize testing, provided that the request is made before April 18th, 2022. to the LOC.</p> <p>The invited participating Federations must pay the tests for their delegation members. We will send the prices of PCR and Antigen tests at the beginning of April 2022.</p>
COVID 19	<p>Besides the FIG medical guidelines for the particular event, FIG also requires all the participants to follow the standard precautions. The FIG requires all participants, judges and officials to take standard precautionary measures, such as frequent hand-washing, wearing masks or face coverings at all times and keeping a physical distance of at least 1.5 metres whenever possible.</p> <p>The only situation in which the safety distance does not have to be respected is when a coach provides assistance (catch, lead, spotting) during an athlete's performance. This phase must be kept as short as possible and the assisting person is obliged to wear a mask throughout. Gymnasts do not need to wear a mask or face covering while they are performing at the training venue or on the FOP and keeping a physical distance of at least 1.5 metres whenever possible.</p> <p>Conditions for entering Serbia concerning Covid-19 can be found on the official site of the Ministry of Foreign Affairs of Serbia: https://www.mfa.gov.rs/en/citizens/travel-serbia/covid-19-entry-requirements</p> <p>For all those who will need a PCR test or Antigen Rapid test for going back home, LOC will organize testing, provided that the request is made before April 18th, 2022 to the LOC.</p> <p>The invited participating Federations must pay for the tests for their delegation members. VISA	<p>Please verify immediately with your travel agent or the Serbian Embassy or Consulate in your country if a visa is required for your travel to Serbia. The LOC will be happy to assist each Delegation member with an official invitation letter, provided that the request is made before March 31st, 2022 to the LOC.</p> <p>The request must include the function, full name, gender, date of birth, citizenship and passport number, passport expiry date, the arrival and departure dates of the Delegation Member as well as the city the visa application support letter must be sent to.</p>
INSURANCE	<p>The Host Federation, the LOC and the FIG will not be held responsible for any liabilities in case of accidents, illness, repatriation and the like.</p> <p>The FIG Technical Regulations foresee that all participating Federations are responsible for making their own arrangements to have the necessary valid insurance coverage against illness, accidents and for repatriation for all the members of their Delegation.</p> <p>The LOC will verify the insurance upon arrival of the delegation members (e.g. cover note or photocopy of the valid policy). Delegation members with insufficient insurance cover must inform the LOC in advance.</p> <p>The LOC will subsequently offer insurance at the Federations own charge as follows: 20€ per person/day.</p>

INTERNATIONAL TRANSPORTATION	The invited participating Federations must pay for the travel costs of their delegation members. The Travel Schedule Form must be returned to the LOC by April 20 th , 2021
