FEDERATIONS INVITED	All FIG Member Federations, who have paid their annual membership fee for Trampoline Gymnastics, according to the following principles: Aere Trampoline Cup is an event open to all clubs affiliated in their respective National Federations, as well as representatives of National and/or Regional federations.						
AGE LIMITS	Age Group: 11-12, Junior (13-16), 17-21 All gymnasts must have a valid FIG licence until the end of the event.						
JUDGES AND JURIES	The number of Judges' panels may be decided by the organizing member federation depending on the number of participating competitors and judges. The Judges' panels will be set up by a draw from the judges present at the event. Each participating federation must provide minimum one judge per discipline in which they participate. Failure to do so will result in a fine of € 500 to be paid to the organizing member federation. The organizing federation is responsible that there are enough FIG brevetted judges present with the appropriate category of brevet for their function. In trampoline gymnastics the judges' panels are as follows: All judges must have a current valid FIG brevet at the time of the event, for the respective discipline.

ENTRY FEES	The cost for the entry fee is 40 € per gymnast. The invited participating federations must pay for all entry fees. At the time of the Definitive registration (March 23rd 2022) 100% of the entry fee must be paid to the LOC. The entry fee is not refundable. Entries without payment of the entry fees will be considered as invalid and will be refused.						
ACCREDITATION	Each delegation will be taken to the accreditation desk upon arrival. The following items will be checked there: - Total payment of costs due to the LOC and / or the FIG - Passports, Names and Date of Birth of the entire delegation - Insurance – every delegation member needs a valid insurance - Travel schedule - National anthem and national flag In addition, the LOC will distribute information regarding the gymnasts' safeguarding plan.						
EVENT FORMAT	This International Tournament will be run in the following four (4) disciplines and three (3) age groups: ○ Individual Trampoline ○ Synchronized Trampoline ○ DMT ○ TUM ○ 11-12 years (following WAGC Rules) ○ 13-16 years (following Junior Rules) ○ 17-21 years (following WAGC Rules) The Aere Cup competition will consist of Qualifications and Finals. <u>Participation in the Qualifications:</u> • All competitors must take part in the qualifications. • No qualifications will be held if there are less than 6 participants per category/discipline. <u>Participation in the Finals:</u> • The top eight gymnasts or pairs from the qualifications qualify for the finals.						

	Cancellation Policy: The organizing committee (LOC) may cancel the competition for a specific category/discipline if at the time of the definitive entry there are less than 6 participants registered in this category. In case of such a cancellation, the LOC must reimburse, in full, the entry fee and payments made for accommodation. Should flights have to be cancelled due to the above, the risk is at the charge of the participating member Federations (NF).

COVID 19	Besides the medical guidelines for the particular event, FIG also requires all the participants to follow the standard precautions. The FIG requires all participants, judges and officials to take standard precautionary measures, such as frequent hand-washing, wearing masks or face coverings at all times and keeping a physical distance of at least 1.5 metres whenever possible. The only situation in which the safety distance does not have to be respected is when a coach provides assistance (catch, lead, spotting) during an athlete's performance. This phase must be kept as short as possible and the assisting person is obliged to wear a mask throughout. Gymnasts do not need to wear a mask or face covering while they are performing at the training venue or on the FOP and keeping a physical distance of at least 1.5 metres whenever possible. Relevant information about procedures, restrictions and any other Covid-19 related action will be released closest to the event depending on actual situation and Italian Government Rules by the time of the event.										
VISA	Please verify immediately with your travel agent or the Italian Embassy or Consulate in your country if a visa is required for your travel to Italy. The Organizing Committee will be happy to assist each delegation member with an official invitation letter, provided that the request is made before March 23rd 2022. The request must include the full name, date of birth, gender, function, passport number, passport expiry date, and the arrival and departure dates of the delegation member as well as the city the visa application letter must be sent to.										
INSURANCE	The Host Federation, the LOC and the FIG will not be held responsible for any liabilities in case of accidents, illness (including COVID-19), repatriation and the like. The FIG Technical Regulations foresee that all participating Federations are responsible for making their own arrangements to have the necessary valid insurance coverage against illness, accidents and repatriation for all the members of their Delegation. Basic insurance (sickness, accident and repatriation) in your country of residence is compulsory in order to be able to benefit from coverage by FIG IMSSA subsidiary insurance. 	If the note has not been sent in advance to the LOC (which is strongly recommended), the LOC will verify the insurance coverage upon arrival of the delegation members (e.g. cover note or photocopy of the valid policy). The insurance must be valid at least starting from the arrival day of the delegation and must last for the delegations' entire stay Delegation members with insufficient insurance coverage must inform the LOC in advance. The LOC will subsequently offer insurance coverage at the Federations own charge as follows: 80 € per person/day.
INTERNATIONAL TRANSPORTATION	The invited participating federations must pay for the travel costs of their delegation members. The Travel Schedule Form must be returned to the LOC by April 27th 2022.
LOCAL TRANSPORTATION	Transfer for delegation members from/to the following airports/railways station are included in the hotel costs, as well as a shuttle service from hotels to venue and back. • "Federico Fellini International Airport" – Rimini (RMI) • Rimini Railways Station Price for transfer from/to "Guglielmo Marconi International Airport" – Bologna (BLQ) is 25 € per person one way (50 € per person for round trip).

Entries without the payment of the 50% of the accommodation costs will be considered as invalid and will be refused. The remaining 50% of the accommodation costs must be paid by April 27th 2022.																								
MEALS	Extra meals can be booked by Federations and will be served at the venue. Cost per meal/person is € 25. While the Extra Meals Form must be returned to the LOC by March 23rd 2022 at the very latest, the costs for the extra meals must be paid to the LOC as follows: - 50% by March 23rd 2022 - 50% by April 27th 2022																								
CANCELATION POLICY	Rooms and meals cancelled from 23rd of March until 26th of April at the very latest will be subject to a cancellation fee of 50% to be paid by the Federation concerned. Rooms and meals cancelled from 27th of April until the arrival of the delegations on site or “no show” will be subject to a cancellation fee of 100% to be paid by the Federation concerned.
