**European Gymnastics is pleased to herein provide you with the Directives for the 28<sup>th</sup> European Championships in Trampoline, Tumbling & Double Mini-Trampoline Gymnastics to be held in Rimini (ITA) from June 1<sup>st</sup> – 5<sup>th</sup>, 2022.**

These European Championships will be organized following the European Gymnastics & FIG Statutes, Technical Regulations, the 2022-2024 TRA, TUM & DMT Code of Points and relevant newsletters, FIG Code of Ethics, FIG Code of Conduct, FIG Code of Discipline, FIG General Judges Rules, FIG Specific Judges Rules, FIG Anti-Doping Rules, European Gymnastics Medical Guidelines, the Medical Organisation of FIG Competitions and Events, the European Gymnastics Guidelines for the return to competitions with the Covid-19 pandemic, the FIG Framework for safeguarding athletes and other participants from harassment and abuse in sport during events, the FIG License Rules, European Gymnastics Media Rules, FIG Apparatus Norms, FIG Advertising and Publicity Rules, FIG Rules for Sanctioning (approval) of International Events and European Gymnastics Accreditation Directives, as well as all other Rules and Guidelines valid starting 01 January 2022 onwards, any possible amendments by the date of these European Championships, and any complements decided in the meantime.

All participating Federations commit to abide by the Statutes and all European Gymnastics & FIG Rules and Regulations. National Federations not respecting them will not be allowed to compete.

## 6. PARTICIPATION RIGHT AND ACCREDITATIONS

Gymnasts holding a valid FIG License and with the correct age from European Gymnastics affiliated member federations in good standing may take part in these European Championships.

### Maximum size of delegation

The maximum size of each delegation, together with the number of transferable access cards (transferable within the Federation's official delegation) as per European Gymnastics Rules for Accreditation is as follows:

\* Reserve gymnasts can only compete if a gymnast is injured; this has to be confirmed by the official doctor.

\*\* Reserves for Trampoline Synchro must come from Trampoline Individual and vice versa.

\*\*\* A full team in TRA/TUM/DMT consists of minimum 3 male and 3 female gymnasts.

\*\*\*\* Participating in junior and senior events of one discipline (TRA, TUM or DMT) with more than 5 registered gymnasts, the NF is obliged to bring two judges per discipline. Participating in junior and senior events of one discipline (TRA, TUM or DMT) with 5 registered gymnasts or less, the NF can bring either one or two judges per discipline. For detailed judges' provisions see Article 10.

### Accreditation Application Process

All Accreditation cards will be distributed at the Accreditation Centre situated at the Competition Venue upon arrival of the delegations.

The following items will be checked there with the Heads of Delegation:

- Passports of the delegation members
- Transport – Departure travel information

- The medical insurance for the members of the delegations, except for the gymnasts and judges, see point 19
- Proof of the fulfilment of all financial obligations to the LOC

Submission of photos in due time will prevent the delegations from waiting at the accreditation centre. **20** EUR will be charged for each photo the LOC has to make at the arrival of the delegation.

## 7. AGE LIMIT OF GYMNASTS

---

**Juniors:** 13 – 16 years (born 2009 – 2006)

**Seniors:** 17 years (born 2005) or older

**All gymnasts must have a current valid FIG licence until the end of the event.**

## 8. REGISTRATIONS AND ENTRY FEES

---

Registrations can only be made by European Gymnastics affiliated federations in good standing, via the SmartScoring Gymdata platform (<https://registry.gymdata.online/>) and by using the National Gymnastics Federations' login and password. An email will be sent to all National Federation once the programme is ready to be used.

### Definitive Registration

The definitive registrations must be completed by entering the composition of the delegation until **March 2<sup>nd</sup>, 2022** (23:59 Swiss time) at the very latest.

### Nominative Registration

The nominative registrations must be completed by entering the composition of the delegation until **May 2<sup>nd</sup>, 2022** (23:59 Swiss time) at the very latest.

### Entry Fees

**The Entry Fee for this event: EUR 150.- per gymnast and per discipline (TRA Individual, TRA Synchro, TUM, DMT. Not for reserve gymnasts).**

The total amount of the entry fees must be paid until the date of the nominative registration deadline, **May 2<sup>nd</sup>, 2022** at the very latest on the European Gymnastics bank account.

Please state the name of the Federation and the payment purpose on the transfer (i.e. 'SUI\_2022 TRA ECH Registration Fees'). The payment must be made in **EUR only**.

Federations which have not fulfilled their financial obligations towards European Gymnastics or FIG (e.g. annual membership fees, unpaid invoices etc.) and the LOC (e.g. accommodation, meals) will not be allowed to participate in these European Championships. In case of non-participation or partial participation the entry fee will not be reimbursed.

### Sanctions

The fines for late registrations are as follows (as per the European Gymnastics Technical Regulations, Art. 3.2.5):

No late registration can be accepted after the drawing of lots.

## 9. LICENSES

---

**No gymnasts will be accepted without a valid FIG License at the deadline of the Nominative Registration.**

In order to be considered, licence application forms (new or renewal) must be submitted to the FIG at least one (1) month prior to the deadline for nominative registration.

Please consult FIG License Rules for additional information in this respect.

## 10. JUDGES AND JURY OF APPEAL

---

**All judges must have a current valid FIG brevet at the time of the event, in the respective discipline.**

All participating federations have to nominate judge(s) with a valid FIG Brevet min. cat. 3 for each discipline (TRA, TUM, DMT) and category (Seniors and Juniors) in which they have competitors according to the following rules:

- Participating in junior and senior event of one discipline (TRA, TUM or DMT) with 5 registered athletes or less, the NF **can bring either one or two** judges per discipline.
- Participating in junior and senior event of one discipline (TRA, TUM or DMT) with more than 5 registered athletes, the NF is **obliged to bring two** judges per discipline.
- If the NF is obliged to bring two judges and the country has at least two judges' cat. 1-2, the NF should send at least one judge cat. 1-2.
- A TRA judge should judge either in Senior or in Junior category only.
- To have a TRA judge in both Senior and Junior category, the NF should send 2 judges.
- In principle, the NF can appoint their judge for the senior or junior event, but the TC is allowed to do a redistribution of the judges from seniors to juniors and vice-versa to ensure proper judges categories in both competitions.
- Exceptions can be approved by the TC President if the proper number of judges according to the FIG rules in all categories is ensured.

According to the General judges' rules 2022-2024 cat. 4 judges cannot judge at Continental Championships in Trampoline Gymnastics. European Gymnastics TC-TRA will start the draw with the highest category judges. Difficulty judges will be drawn from cat. 1 and cat. 2 judges.

**If a federation does not enter a judge or comes with a judge of an insufficient level, European Gymnastics will request the payment of a fine of EUR 2'000,- per missing judge.**

#### **Judges shall recuse themselves if**

- They are or were married to or live in a registered partnership or co-habit with a gymnast
- They are related to a gymnast by birth or marriage in direct or in collateral line, including the following persons: grandparent, parent, uncle, aunt, brother, sister, child, grandchild, nephew and cousin.

#### **Jury of Appeal**

The Jury of Appeal consist of two members of the Executive Committee (one acting as President) and a third person to be designated in accordance with the matter of the appeal. In case of a judge's appeal, a person not involved in the decision of the Superior Jury and in the judging process will be nominated.

The composition of the Jury of Appeal will be communicated in the Workplan.

### **11. DRAWING OF LOTS**

The gymnasts' drawing of lots will decide the starting order of the qualification competitions and the finals. It will take place on May 10<sup>th</sup>, on zoom with representatives of the European Gymnastics TC-TRA and the European Gymnastics Sports Coordinator.

### **12. COMPETITION FORMAT AND PROGRAMME**

The Championship will be organised in following disciplines:

- Individual Trampoline (individual, team)
- Tumbling (individual, team)
- Double Mini-Trampoline (individual, team)
- Synchronised Trampoline

in both age categories (juniors and seniors) and genders (boys and girls / men and women). Three (3) gymnasts per team compete in team finals.

## **19. INSURANCE**

---

The FIG insurance IMSSA (International Medical & Security Sports Assistance) for gymnasts and judges with a valid FIG License / Brevet is valid for these European Championships. Please address to the information on the FIG Intranet.

**All other delegation members are NOT included in this insurance and must present a proof of insurance at the accreditation.**

The Host Federation, the LOC and European Gymnastics and the FIG will not be held responsible for any liabilities in case of accidents, illness, repatriation and the like.

The FIG Technical Regulations foresee that all participating Federations are responsible for making their own arrangements to have the necessary valid insurance coverage against illness, accidents and for repatriation for all the members of their Delegation.

The LOC will verify the insurance of the delegation members (e.g. cover note or photocopy of the valid policy) upon arrival. Delegation members with insufficient insurance cover must inform the LOC in advance.

The LOC will subsequently offer insurance at the Federations own charge as follows: 80 EUR per person per day / from May 29<sup>th</sup> – to June 6<sup>th</sup>, 2022.

Should at a later stage the event will have to be cancelled the LOC will try its' best to handle the force majeure situation. However, the financial responsibility for all bookings (travel, accommodation, meals) remains with the NF.


