<b>DEFINITIVE SCHEDULE</b>	The detailed program of activities with definitive schedules will be sent to the National Federations after the Nominative Registration deadline.
<b>MEDICAL SERVICE</b>	The medical care will be fully guaranteed by the LOC. The guarantee includes the first aid on site during official training, warm up and competition periods.
<b>COVID-19</b>	<p>All participants will take the COVID-19 test upon arrival at the official hotels and must remain in their rooms until the final result.</p> <p>During the entire training and competition period, participants must circulate only in the sport facilities assigned to the event and in the official hotels. In addition to the medical guidelines for the particular event, the FIG requires participants to follow standard precautions.</p> <p>FIG requires all participants, judges and officials to take standard precautionary measures, such as washing their hands and using a mask at all times and, when possible, to keep a physical distance of at least 1.5 meters.</p> <p>The only situation in which it is possible that the safety distance may not be respected is when the coach assists the gymnast during their performances (catching, directing, guarding). This phase should be as short as possible and the person assisting is obliged to use a mask during this time</p> <p>Gymnasts do not need to wear a mask or cover their faces during their performance; in the training area or in the competition area and as far as possible they should maintain a physical distance of at least 1.5 m. physical distance.</p> <p>Additional information will be included in the Work Plan and will be sent to the Federations prior to the event.</p>
<b>VISA</b>	<p>Please verify immediately with your travel agent or the Colombian Embassy or Consulate in your country if a visa is required for your travel to Colombia.  <a href="http://www.cancilleria.gov.co/tramites_servicios/visa/requisitos">http://www.cancilleria.gov.co/tramites_servicios/visa/requisitos</a></p> <p>The LOC will be happy to assist each Delegation member with an official invitation letter, provided that the request is made before April 24<sup>th</sup> 2022 to the LOC.</p> <p>The request must include the function, full name, gender, date of birth, citizenship and passport number, passport expiry date, the arrival and departure dates of the Delegation Member as well as the city the visa application support letter must be sent to.</p>
<b>INSURANCE</b>	<p>The Host Federation, the LOC and the FIG will not be held responsible for any liabilities in case of accidents, illness, repatriation, and the like.</p> <p>The FIG Technical Regulations foresee that all participating Federations are responsible for making their own arrangements to have the necessary valid insurance coverage against illness, accidents and for repatriation for all the members of their Delegation.</p> <p>Basic insurance (sickness, accident and repatriation) in your country of residence is compulsory in order to be able to benefit from coverage by FIG IMSSA subsidiary insurance.
