LICENCES	<p>All gymnasts need to have a valid FIG license until the end of the event and a CONSUGI license CONSUGI (2021-2022).</p> <p>CONSUGI LICENCE:</p>																																																												

	<p>For the year 2022, the value of the licence is \$ 15 USD. This licence is valid until December 31st, 2022. The athletes who competed in the South American Championship 2021, do not have to pay the licence.</p> <p>For the year 2023, all gymnast Will have to pay the CONSUGI licences again.</p> <p>LICENCIA FIG: All gymnasts in the JUNIOR and SENIOR categories, in addition to presenting their CONSUGI license, must present their current FIG license. All delegations are requested to check their validity on the official pages. https://www.gymnastics.sport/site/athletes/lic_view.php</p>						
<p>JUDGES AND JURIES</p>	<p>All judges must have a current valid FIG brevet at the time of the event. Every Federation must send 2 judges with a valid FIG Brevet of the current cycle, for all the competition. The judges panel must have a minimum of: 4 Artistic Judges 4 Execution Judges 2 Difficulty Judges 1 Chair of Judges Panel</p> <p>Those Federations that do not send at least 2 judges, must pay the sum of USD 1,200. to cover the costs of an invited judge. The National Federation shall inform the CONSUGI in advance (at least at the time of the nominative registration). PARTICIPATION	<p>The South American Championship consists of Qualifications and Finals in all categories.</p> <p>In the qualifications, a maximum of 4 athletes per category per country may appear.</p> <p>Final: Eight (8) gymnasts per category will go to the final (Maximum 2 per country per category).</p> <p>If the Organizing Federation has not classified in any category, it will be able to decide in which it wishes to participate by category. (Only one per category you prefer).</p>

	<p>Therefore, the maximum number of participants in the final phase is 8 + 1 in one category and 8 gymnasts in the other categories.</p> <p>The participant with the "wild card" should have participated in the respective category during the qualifying rounds and may receive medals.</p> <p>The cost per additional person (Coaches, Team leaders, Doctors, Paramedical Staff and guests) will be of \$ 100.00 USD each, which grants them, the same rights granted to the members of the delegation.</p>																						
AWARDS	<p>Medals will be given to the first three places in each Age Categories, and in each of the disciplines. Certificate of participation will be awarded to all competitors and officials. No prize money will be given.</p>

This request must include the function, full name, gender, date of birth, citizenship, passport number, passport expiration date, arrival and departure dates of the Delegation Member</p>																						
INSURANCE	<p>The Host Federation, the LOC, the CONSUGI and the FIG are NOT responsible in case of accidents, illnesses, repatriation or the like.</p> <p>The FIG Technical Regulations foresee that all participating federations are responsible for making their own arrangements to have the necessary valid insurance coverage against illness, accidents and for repatriation for all the members of their delegation.</p> <p>Basic insurance (sickness, accident and repatriation) in your country of residence is compulsory in order to be able to benefit from coverage by FIG IMSSA subsidiary insurance. The insurance must be valid at least starting from the arrival day of the delegation and must last for the delegations' entire stay.</p> <p>The LOC will offer insurance to the Federations at a cost of: USD 45.00 per person.</p>
COVID 19	<p>Besides the medical guidelines for the particular event, FIG also requires all the participants to follow the standard precautions.</p> <p>The FIG requires all participants, judges and officials to take standard precautionary measures, such as frequent hand-washing, wearing masks or face coverings at all times and keeping a physical distance of at least 1.5 metres whenever possible.</p> <p>The only situation in which the safety distance does not have to be respected is when a coach provides assistance (catch, lead, spotting) during an athlete's performance. This phase must be kept as short as possible and the assisting person is obliged to wear a mask throughout.</p> <p>Gymnasts do not need to wear a mask or face covering while they are performing at the training venue or on the FOP and keeping a physical distance of at least 1.5 metres whenever possible.</p> <p>In order to travel to Peru, all people must previously fill out the Declaration of Health (https://e-notificacion.migraciones.gob.pe/dj-salud/) within 72 hours prior to the trip. The registration is individual and in the case of a minor, it is carried out by the guardian or person in charge of the traveler.</p> <p>12 years old and older travellers must prove (by showing the physical or digital certificate) that they have completed the vaccination schedule against COVID-19 (two doses or the Janssen single dose) in Peru or abroad. Otherwise, a negative molecular test (PCR) can be presented with a result date that is not more than 48 hours before the time of shipment at its point of origin.</p> <p>The use of a double three-fold mask or 1 KN95 mask is mandatory to circulate in public spaces and in closed places. Children under two years of age are exempt from wearing a mask.</p>
INTERNATIONAL TRANSPORTATION	<p>Federations, clubs, leagues or institutes that practice aerobic gymnastics invited to participate must cover the costs of their air tickets to the city of LIMA.</p> <p>The Local Organizing Committee will provide transportation from the Lima airport to the hotels and vice versa for all the members of the delegation duly registered and accredited by the participating Federations.</p> <p>The Travel Itinerary Form must be completed and sent to the LOC before July 20, 2022.</p>
LOCAL TRANSPORTATION	<p>The Local Organizing Committee will provide local transportation from the airport to the hotel and vice versa for all members of the delegation duly registered and accredited by the participating Federation.</p>
