SELECTION PROCEDURES FOR MEN'S ARTISTIC JUDGES



Order of selection

- Difficulty judges
- Execution judges
- Reserve judges

Rules for all judges nominated

- One judge per NOC
- No current Federation President or Secretary General at time of nomination through the end of the 2024 Olympic Games Paris
- No Warning Letter or Sanction during current cycle

Difficulty (D) Judges

<ul style="list-style-type: none">• Category 1 only
<ul style="list-style-type: none">• Experience - must have served as a D judge OR Superior Jury Member at a Senior World Championships or Junior World Championships during the current cycle
<ul style="list-style-type: none">• Highest Difficulty Examination Result from the last Intercontinental Judges' Course, D judges from Tokyo OG are not eligible for the first step of the selection of these D positions. The second step of the selection, if necessary, will be a draw from the remaining Category 1 Judges, including those judges who may have been a D judge at the Tokyo OG and fulfill criteria mentioned above.
<ul style="list-style-type: none">• Tie-break: Most D or Superior Jury phases judged during the present cycle

Execution (E) Judges

<ul style="list-style-type: none">• Category 1 or 2 only (no initial priority based on category) brevet awarded for a minimum of 2 cycles
<ul style="list-style-type: none">• Experience (Minimum Eligibility)- must have served as a D or E judge at a minimum of two competitions from the following: 2022 World Championships, 2023 World Championships, 2023 Junior World Championships and/or the 2023 World Cup series events. One competition must be a Senior or Junior World Championships during the current cycle.
<ul style="list-style-type: none">• Total of the best 2 phases JEP Execution Marking Scores from the 2022 World Championships, 2023 World Championships, 2023 Junior World Championships and/or the 2023 World Cup series events. (Counting a maximum of one Apparatus Final, the best one). Note: the two phases could be from the same competition.



<ul style="list-style-type: none"> Scoring Evaluation: JEP Marking scores with PCVR from the Senior and Junior WCH, all other competitions with JEP Marking scores and no PCVR using the evaluation during the competition (Early Warning)
<ul style="list-style-type: none"> No significant bias- No individual E score given by a judge to a gymnast of more than +0.3 above the JEP control score of 8.0 or more and +0.4 above for a JEP control score of 7.0-7.99 for their own federation (applies to all phases judged, based on all notes considered for the JEP control score. If any individual note used in the JEP calculation is the same as or within 0.1 the judge showing bias, the bias is NOT confirmed and the judge is eligible.
<ul style="list-style-type: none"> No "Poor" JEP classification during the current cycle from JEP at any phase of the judge selection competitions. This applies only for competitions that have a Post Competition Video Review (PCVR). In the event of a "Poor" JEP classification from a World Cup, that Judge's individual score(s) will be video reviewed by the TC (5 members). If the Judges' score(s) is within 0.3 of the TC average of the 3 middle scores for any "Out of Consensus Evaluations", the judge will retain eligibility in the selection procedure.
<ul style="list-style-type: none"> Tie-break- Average Score of all JEP Marking Scores from the current cycle, using a maximum of one Apparatus Final
<p>Exception- Once the final nomination list is determined, and a line is drawn below the last judge, if there are two or more judges from the same federation listed above the last judge nominated, the highest ranked Category 1 by JEP from that federation prevails. Category 2 with Reward letter(s)- takes priority over other judges of the same Category from the same federation</p>

Reserve Judges

<ul style="list-style-type: none"> The next judges below those nominated for E positions
<ul style="list-style-type: none"> Guaranteed to actively judge a minimum of one phase as an E judge at the OG

Contingency

In case there are not enough eligible judges based on competitions and phases, a JEP total will be calculated using the following parameters in order:

- 1 Competition and 2 phases (maximum 1 Apparatus Final), if still not enough eligible judges,
- 1 Competition and 1 phase

Priority for each contingency parameter above:

Experience as a E judge at a World Championship during the cycle

A Phase is defined as:

- At a World Championship or World Cup, any competition segment, i.e., Qualification (by 1 or 2 days), Team Final, AA Final or Apparatus Finals (by each apparatus) is considered as a phase.
