<b>VISA</b>	<p>Please verify immediately with your travel agent or the French Embassy or French Consulate in your country if a visa is required for your travel to France.</p> <p>The LOC will be happy to assist each Delegation member with an official invitation letter, provided that the request is made on time (<b>at least 6 weeks before the competition = February 24<sup>th</sup> 2023</b>) to the LOC.</p>		

	The request must include the function, full name, gender, date of birth, citizenship and passport number, passport expiry date, the arrival and departure dates of the Delegation Member as well as the city the visa application support letter must be sent to.
<b>INSURANCE</b>	<p>The Host Federation, the LOC and the FIG will not be held responsible for any liabilities in case of accidents, illness, repatriation and the like.</p> <p>The FIG Technical Regulations foresee that all participating Federations are responsible for making their own arrangements to have the necessary valid insurance coverage against illness, accidents and for repatriation for all the members of their Delegation.</p> <p>Basic insurance (sickness, accident and repatriation) in your country of residence is compulsory in order to be able to benefit from coverage by FIG IMSSA subsidiary insurance. <b>TRANSPORTATION</b>	<p>The invited participating federations must pay for the travel costs of their delegation members to/from France.</p> <p>The LOC will cover the transportation to/from hotel from the airport Charles de Gaulle (Roissy en France), from the airport Orly Airport, Parisians train stations upon arrival and by departure. The LOC will not cover the transportation to/from over airports except the mentioned.</p> <p>The LOC will cover the transportation to/from hotel to/from the Competition Hall.</p> <p>The Travel Schedule Form must be returned to the LOC before <b>March 24<sup>th</sup> 2023</b>. <b>If delegations will send travel plan later than march 24<sup>th</sup> 2023, then the local transportation from airports or train stations will not be guaranteed.</b></p>
