


ENTRY FEES	<p>The non-reimbursable cost for the entry fee is of US \$50 per gymnast per category.</p> <p>The invited participating federations must pay for all entry fees. At the time of the Definitive Registration on 8th April 2024 100% of the entry fee must be paid to the LOC. The entry fee is not refundable and all the necessary bank handling costs should be paid by the participating federations.</p>									
ACCREDITATION	<p>At the accreditation, the heads of delegation must present the following:</p> <ul style="list-style-type: none"> - Passports of all the members of the delegation - Licenses for FIG competitors - One CD for each one routine - Valid Insurance <p>In addition, the LOC will distribute information regarding the gymnasts' safeguarding plan.</p>									
COMPETITION FORMAT	<p>The 9th Junior Asian Championship consists of Qualifications and Finals in all 7 categories.</p> <p>Participation in the Qualification:</p> <ul style="list-style-type: none"> ▪ 9 entries from 4 nations - Final 8 best gymnasts. ▪ 7-8 entries from 4 nations - Final 6 best gymnasts. ▪ 5-6 entries from 3 nations - Final 4 best gymnasts. ▪ Less than 4 entries from 2 nations - Cancel of the respective category <p>Participation in the Finals: The top eight scores (respectively 6, 4) per category from the Qualification qualify for the Finals.</p> <ul style="list-style-type: none"> - In addition, if the Organizing Member Federation has not qualified in any category, it may nominate one participation in max. 1 category of its choice. - Maximum participation in the finals is therefore 8+1 (respectively 6+1 or 4+1) participants in one category and 8 (respectively 6 or 4) in the other four categories. <p>The organizing member Federation may cancel the competition in the respective category if at the time of the definitive entry, there are less than 4 countries registered in a category.</p> <p>In case of such a cancelation, the organizing member Federation must reimburse, in full, payments made for accommodation. Should flights have to be cancelled due to the above, the risk is at the charge of the participating member Federations.</p>

VISA	<p>Please verify immediately with your travel agent or the Vietnam Embassy or Consulate in your country if a visa is required for your travel to Vietnam. The LOC will be happy to assist each Delegation member with an official invitation letter, provided that the request is made before 8th April, 2024 to the LOC. Participating federations must pay for the visa of their delegation members.</p> <p>The request must include the function, full name, gender, date of birth, citizenship and passport number, passport expiry date, the arrival and departure dates of the Delegation members as well as the city the visa application support letter must be sent to.</p>	
INSURANCE	<p>The Host Federation, the LOC, AGU and the FIG will not be held responsible for any liabilities in case of accidents, illness (including COVID-19), repatriation and the like.</p> <p>The AGU/FIG Technical Regulations foresee that all participating Federations are responsible for making their own arrangements to have the necessary valid insurance coverage against illness, accidents and repatriation for all the members of their Delegation.</p> <p>Basic insurance (sickness, accident and repatriation) in your country of residence is compulsory in order to be able to benefit from coverage by FIG IMSSA subsidiary insurance. Please also refer to https://www.gymnastics.sport/site/pages/medical-insurance.php for additional information regarding the FIG IMSSA insurance for Athletes and Judges. The LOC will verify the insurance coverage upon arrival of the delegation members (e.g. cover note or photocopy of the valid policy). SAFEGUARDING	From the official event day of arrival until the official day of departure, participants (gymnasts, coaches, judges and any other delegation members) have the possibility to contact by phone or e-mail the LOC Safeguarding Officer in case of	

	<p>harassment and abuse of any type or if they are worried and do not feel comfortable.</p> <p>The information regarding the LOC Safeguarding Officer will be communicated upon arrival of the delegations on site.</p> <p>In addition, posters of the “10 Golden Rules of Gymnastics”, the FIG campaign to raise awareness about youth protection in Gymnastics, will have to be displayed in several locations, including training and warm-up halls and public zones.</p>														
INTERNATIONAL TRANSPORTATION	<p>The invited participating federations must pay for the International travel costs of their delegation members.</p> <p>The Travel Schedule (including flight schedule) Form must be returned to the LOC by 8th May, 2024</p>														
LOCAL TRANSPORTATION	<p>From 8th May, 2024 International Airport to the Hotel transportation will be provided by LOC.</p> <p>Bus service will be available for the local transportation of all accredited persons (if applicable) from the official hotels to the training, warm-up, and competitions venues as well as to any other official activities and back as needed.</p>

FINAL BANQUET	<p>On 10th Jun, 2024 after the Finals, there will be Farewell Party. The LOC provides for the official delegation for FREE of charge.</p> <p>All other persons willing to attend this Banquet will be entitled to do so, provided that a request will be send in writing to the LOC via the “Meals” Form and that the amount of US \$50 per person will be paid in full to the LOC by 8th May, 2024</p>

JUDGES AND JURIES	<p>All judges must have a current valid FIG brevet at the time of the event.</p> <p>The number of Juries (Judge’s Panel) may be decided by the Local Organizing Committee with approval of AGU which is depending on the number of participating competitors and judges.</p> <p>The Juries are set up by a draw – directed by the AGU AER TC President – from the judges present at the event. Priority will be given to the judges of the highest category.</p> <p>A jury must consist of 1 Chair of Judges Panel, 4 Artistry, 4 Execution and 2 Difficulty judges.</p>														

	<p>A federation may not have a judge on both the execution and artistic panels. The Chair of Judges Panel and the difficulty judges should also be from different federations. The CJP must be of Category 1. The Difficulty Judges must be Category 1 or 2 The Execution and Artistry judges must be Category 1, 2, 3 or 4.</p> <p>If, on the day of the competition, there is not sufficient number of judges in the requested categories, the Technical Delegate may take whatever action needed to secure the running of the event.</p> <p>Each participation federation must provide minimum one judge. If the federation provides two judges, then one judge is preferred to be Category 3 and above if possible. Failure to do so will result in a fine of US \$1,000 to be paid to the Organizing Federation before 8th May, 2024;</p> <p>The Organizing Federation is responsible that there is enough FIG brevetted judges present with the appropriate category of brevet for their function.</p>																						
DOPING CONTROL	Anti-doping controls will be organized by the International Testing Agency (ITA) on behalf of the FIG and according to the WADA code, Standards and FIG Anti-Doping Rules.
