<b>FINANCIAL OBLIGATIONS</b>	<p>Federations which have not fulfilled their financial obligations towards the FIG or the LOC may not be allowed to participate in this FIG World Challenge Cup. Federations which have not fulfilled their financial obligations towards the Organizing Member Federation by the given deadlines mentioned in these Directives may still have the possibility to participate, but the Organizing Member Federation will not guarantee the hotel booking, meals, and local transportation.</p> <p>Federations which have not fulfilled their financial obligations towards the Organizing Member federations upon arrival will not be accredited.</p>																																				
<b>FEDERATIONS INVITED</b>	<p>The Organizing member federation may invite FIG member federations in good standing at their discretion, but must invite at least all Member Federations which had:</p> <ul style="list-style-type: none"> <li>– gymnasts ranked 1-50 per apparatus in the Qualifications at the last World Championships preceding the respective World Challenge Cup Series.</li> </ul>																																				
<b>PARTICIPATION AND FIG LICENCE</b>	<p>Only senior gymnasts in good standing with the correct age and holding a valid FIG License may participate. The Organizing Committee will be responsible for checking the validity of the gymnasts' licenses. No gymnasts will be accepted without a valid FIG License at the deadline of the Nominative Registration. While the Organizing Member Federation may limit the maximum number of gymnast per delegation, except for the eligible gymnasts, the maximum size of the invited delegation is as follows:</p> <p><b>The Organizing Member Federation may limit the maximum number of gymnast per delegation, except for the eligible gymnasts. <b>ENTRY FEES</b>	<p>The non-reimbursable cost for the Entry Fee (approved by the FIG) is of 50,- € per gymnast (<b>important note:</b> Federations which choose <b>OPTION I</b> will not pay entry fees)</p>										
<b>ACCREDITATION</b>	<p>An accreditation system will be set up upon arrival of the delegations at the competition venue. All officials and delegation members will need an accreditation to enter the training and competition halls.</p> <p>In addition, the LOC will distribute information regarding the safeguarding Officer operations plan upon accreditation.</p>										
<b>COMPETITION FORMAT</b>	<p>The World Challenge Cup competitions consist of:</p> <p>Qualifications and Apparatus Finals</p> <p><u>Qualifications:</u></p> <ul style="list-style-type: none"> <li>▪ Participation is limited to 2 gymnasts per NF on each apparatus.</li> <li>▪ In addition, the Organizing Member Federation is allowed to name a max. of 4 “hors concours” competitors (from the Organizing Member Federation) in Women’s Artistic Gymnastics and a max. of 4 “hors concours” competitors (from the Organizing Member Federation) in Men’s Artistic Gymnastics for a total of 8 “hors concours” gymnasts (i.e. while one “hors concours” gymnast can compete on more than one apparatus, not more than one “hors concours” gymnast can compete on an apparatus). They must be named at the time of the closing of the nominative registration and they cannot qualify for the Finals. <b>DRAWING OF LOTS</b>	<p>The gymnasts' drawing of lots for all FIG World Challenge Cup events will take place on site, during the orientation meeting or during a separate function organized for that purpose with invitation to all participating NFs.</p> <p>At the time of the nominative registration, the apparatus on which the gymnast will compete must be mentioned. Modifications can be made until accreditation. Gymnast may be changed and apparatus can be added as long as 2 gymnasts/apparatus/NF is respected.</p>

<b>MEDICAL SERVICES</b>	Medical services (in co-operation with the organizing committee and the Croatian Gymnastics Federation).
<b>COVID 19</b>	The LOC should follow local guidelines in management of COVID-19. The LOC must facilitate COVID-19 testing for delegations when it is required to have a negative test for return to their country.

<b>ANTI-DOPING</b>	<p><b><u>Doping controls</u></b> Doping controls will be organised by the International Testing Agency (ITA) on behalf of the FIG and according to the World Anti-Doping Code (WADC), the international standards enacted by the World Anti-doping Agency (WADA) and FIG Anti-Doping Rules.</p> <p><b><u>Host federation WADC compliance</u></b> The exploitation of any rights related to the hosting of an event is subject, at all times, to the compliance with the WADC and the international standards enacted by WADA. Regardless of whether the event has already been allocated or not, the FIG may terminate any collaboration with the host federation or the LOC, immediately and without paying any penalty and/or compensation or incurring liability of any kind, under the following circumstances:</p> <ul style="list-style-type: none"> <li>(i) if the National Anti-Doping Organisation (NADO) in charge in the concerned country is declared non-compliant by WADA</li> <li>(ii) if the relevant country has been ruled ineligible to host the event.</li> </ul> <p>In such cases, the FIG is entitled to reassign the event to any other host federation in another country where the WADC and the WADA international standards are fully respected.</p>
<b>VISA</b>	<p>Please verify immediately with your travel agent or the <b>Croatian Embassy</b> or Consulate in your country if a visa is required for your travel to <b>Republic of Croatia</b>. The Organizing Committee will be happy to assist each Delegation member with an official invitation letter, provided that the request is made before <b>4<sup>th</sup> February 2024</b> to the LOC.</p> <p>The request must include the function, full name, gender, date of birth, citizenship and passport number, passport expiry date, the arrival and departure dates of the Delegation Member as well as the city the visa application support letter must be sent to.</p>
<b>INSURANCE</b>	<p>The Host Federation, the LOC and the FIG will not be held responsible for any liabilities in case of accidents, illness (including COVID-19), repatriation and the like.</p> <p>The FIG Technical Regulations foresee that all participating Federations are responsible for making their own arrangements to have the necessary valid insurance coverage against illness, accidents and repatriation for all the members of their Delegation.</p> <p>Basic insurance (sickness, accident and repatriation) in your country of residence is compulsory in order to be able to benefit from coverage by FIG IMSSA subsidiary insurance. 	<p>The insurance must be valid at least starting from the arrival day of the delegation and must last for the delegations' entire stay Delegation members with insufficient insurance coverage must inform the LOC in advance. The LOC will subsequently offer insurance coverage at the Federations own charge.</p>
<b>INTERNATIONAL TRANSPORTATION</b>	<p><b>The invited participating federations must pay for the travel costs of their delegation members.</b> The Travel Schedule Form must be returned to the LOC by <b>4<sup>th</sup> February 2024</b></p>
<b>LOCAL TRANSPORTATION</b>	<p>Local Transportation between Osijek and Zagreb airport, Osijek airport and Osijek train and bus station to the hotels and between the hotels and the competition venue will be provided by the LOC for all delegation members at no extra cost to the delegations that book their accommodation through the LOC. Otherwise the cost of € 50 (per delegation member) for the local transportation must be paid to the OC by <b>4<sup>th</sup> February 2024.</b></p>

**WINNER OF THE ANNUAL WORLD CHALLENGE CUP SERIES**

The winner of the annual World Challenge Cup Series is the gymnast with the highest number of points on the respective apparatus after the last event of the year, taking into consideration the best results (maximum 3), regardless of the number of competitions the athletes participated in.

Should there be a tie after the last competition, it will be broken as follows:

- a. The ranks of the max. three (3) counting exercises will be added and the gymnast with the lowest total prevails.  
Note: in case of a tie in the ranks to determine the three counting exercises, the exercises with the highest final scores will prevail.
- b. If the tie remains, the final scores of the max. three (3) counting exercises will be averaged and the gymnast with the highest average prevails.
- c. If the tie remains, the total E-scores of the max. three (3) counting exercises (max. six (6) scores for Vault) will be averaged and the gymnast with the highest average prevails.
- d. If the tie remains, the total D-scores of the max. three (3) counting exercises (max. six (6) scores for Vault) will be averaged and the gymnast with the highest average prevails.

A special award ceremony must be held at the last World Challenge Cup Competition of the year in which the World Challenge Cup series winners shall receive a Cup.

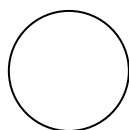
