

JUDGES AND JURIES	<p>All judges must have a current valid FIG brevet at the time of the event for the respective discipline RGI and RGG.</p> <p>Each federation may bring up to 2 judges per discipline.</p> <p>All judges must be minimum Cat III- , Those Continental championships are considered as Group 3 competitions for RG.</p> <p>Any Cat IV judges registered can only be used as Time or Line Judges or according to FIG EC approval.</p> <p>According to FIG Technical Regulations no judging panel may include more than one member from a single federation.</p>																																
ENTRY FEES	<p><u>COMPETITION ENTRY FEE:</u></p> <p>The invited participating federations must pay entry fee at the time of the Definitive registration which is 25 February 2024, as follows:</p> <ul style="list-style-type: none"> • Participation with only one (1) gymnast in a discipline: USD 50 (per discipline) • Participation with more than one gymnast in a discipline: USD 150 (per discipline, flat fee for the team) <p>The entry fee is non-refundable and payable to the UAG.</p> <p><u>ANNUAL UAG AFFILIATION FEE:</u></p> <p>Federations that have not yet paid their annual affiliation fee for 2024 to the UAG must also make payment to the UAG before they will be allowed to participate in the competition, as follows:</p>

DOPING CONTROLS	Doping controls will be organized by the International Testing Agency (ITA) on behalf of the FIG and according to the World Anti-Doping Code (WADC), the international standards enacted by the World Anti-Doping Agency (WADA) and FIG Anti-Doping Rules.	
COVID 19	The LOC should follow local guidelines in management of COVID-19. The LOC must facilitate COVID-19 testing for delegations when it is required to have a negative test for return to their country.	
VISA	Please verify immediately with your travel agent or the Rwanda Embassy or Consulate in your country if a visa is required for your travel to Rwanda . The LOC will be happy to assist each Delegation member with an official invitation letter, provided that the request is made before 10 March 2024 to the LOC. The request must include the function, full name, gender, date of birth, citizenship and passport number, passport expiry date, the arrival and departure dates of the Delegation Member as well as the city the visa application support letter must be sent to.	
INSURANCE	The Host Federation, the LOC and the FIG will not be held responsible for any liabilities in case of accidents, illness (including COVID-19), repatriation and the like. The FIG Technical Regulations foresee that all participating Federations are responsible for making their own arrangements to have the necessary valid insurance coverage against illness, accidents and repatriation for all the members of their Delegation. Basic insurance (sickness, accident and repatriation) in your country of residence is compulsory in order to be able to benefit from coverage by FIG IMSSA subsidiary insurance. LOCAL TRANSPORTATION	<p>The Organising committee will provide transportation from Kigali international Airport to Hotel for the delegation booked their accommodation through the LOC.</p> <p>Also, transportation between hotel, training, warm up and competition venue will be provided by LOC</p>
