<b>VISA</b>	<p>Please verify immediately with your travel agent or the Czech Embassy or Consulate in your country if a visa is required for your travel to the Czech Republic.</p> <p>The Organizing Committee will be happy to assist each delegation member with an official invitation letter, provided that the request is made before April 24<sup>th</sup>, 2024 to the LOC.</p> <p>The request must include the function, full name, gender, date of birth, citizenship, passport number, passport expiry date, the arrival and departure dates of the Delegation Member as well as the city the visa application support letter must be sent to.</p>
<b>INSURANCE</b>	<p>The Host Federation, the Organizing Committee and the FIG will not be held responsible for any liabilities in case of accidents, illness, repatriation and the like.</p> <p>The FIG Technical Regulations foresee that all participating Federations are responsible for making their own arrangements to have the necessary valid insurance coverage against illness, accidents and for repatriation for all the members of their Delegation.</p> <p>The LOC will verify the insurance upon arrival of the delegation members (e.g. cover note or photocopy of the valid policy). Delegation members with insufficient insurance cover must inform the LOC in advance.</p> <p>Basic insurance (sickness, accident and repatriation) in your country of residence is compulsory in order to be able to benefit from coverage by FIG IMSSA subsidiary insurance.
