5. PARTICIPATION AND ACCREDITATIONS

All NFs in good standing are entitled to participate with a full quota of max. 8 men junior and 8 women junior.

The size of delegation is as follows.

Athletes can participate in both events provided that the maximum athlete quota place per event (max.4) is not exceeded.

For other delegation members, see FIG Accreditation Rules.

6. COACHES

To be registered on the competition every coach should have a coach-sport profile in the FIG database (please see FIG official communication of 31 March 2021). No coach will be accepted without a valid coach-sport profile at the deadline of the Nominative Registration.

In order to be considered, the coach-sport profile (including the documents) must be submitted at least two (2) weeks prior to the deadline for nominative registration.

Only registered coaches can access the Field of Play during training.

7. AGE LIMITS

Minimum 14 years old in the year of the competition (born in 2010)

Maximum 16 years old in the year of the competition (born in 2008)

8. LICENSES

No Athletes will be accepted without a valid FIG License (at the date of the Nominative Registrations).

Please consult the FIG License Rules for additional information in this respect.

9. JUDGES AND JURY OF APPEAL

Judges

Each Judges' Panel consists of:

Speed: 1 Chair of Judges' Panel (CJP), 1 Start Line and 2 Time Judge (ST/T), 4 check-point or line judges (CP/L)

Speed judges are drawn from the list of FIG Parkour judges from the participating federations and FIG nominated judges, with the CJP directing their work. Any open judge positions will be nominated by FIG.

Freestyle: 8 judges (3 per Difficulty and 3 per Execution) will judge, including one Difficulty judge who is also acting as CJP. 2 Line Judges can be used.

Difficulty judges are nominated and invited by the FIG. Execution judges are drawn from the participating federations on-site and attend at the expense of their NF.

Jury of Appeal and Supervisory Board

For the composition of the Jury of Appeal, please consult the FIG Technical Regulations.

The Jury of Appeal will be decided in due time and listed in the Work Plan.

10. REGISTRATION DEADLINE

Registrations can only be made by FIG affiliated federations in good standing, via the **FIG** on-line system and by using the National Gymnastics Federations' login (e-mail) and password.

Definitive Registration

The definitive registrations must be completed by entering the composition of the delegation by 23:59 CET (Swiss Time) on Wednesday, 11 September 2024 at the very latest.

Nominative Registration

The nominative entries must be completed by entering the composition of the delegation by 23:59 CET (Swiss Time) on Wednesday, 09 October 2024 at the very latest. .

Together with the nominative registration and to accelerate the process of the accreditation, the delegations must send one passport photo of each delegation member to jkoslacz@fig-gymnastics.org.

Requirements for each identity colour photo:

- Identity: country_code_event_level_function_full name, for example: CHN_WCH PK_Team Manager_LI Haoyang
- File format: .jpg or .jpeg
- Dimensions: min. 175 X 225 pixels, max. 1750 X 2250 pixels (width X height)
- File size: max. 2MB

Accreditations sent without photos will not be handled with priority. You may have to wait at the accreditation desk upon arrival.

After the drawing of lots, no athlete can be added. No additional athlete may appear on the Nominative Registration or at accreditation.

Please consult the FIG Technical Regulations for additional information in this respect.

11. DRAWING OF LOTS

The athletes drawing of lots will decide the starting order of the qualification competitions. It will take place during the orientation meeting.

Athletes have the possibility to withdraw from an event until the morning of the draw.

15. VISA

Please verify immediately with your travel agent or the Japanese Embassy or Consulate in your country if a visa is required for your travel to Japan. An official invitation letter will be sent, provided that the request is made before **20 September 2024**. The request must include the full name, date of birth, gender, function, passport number, passport expiry date, and the arrival and departure dates of the delegation member as well as the city the visa application letter must be sent to.

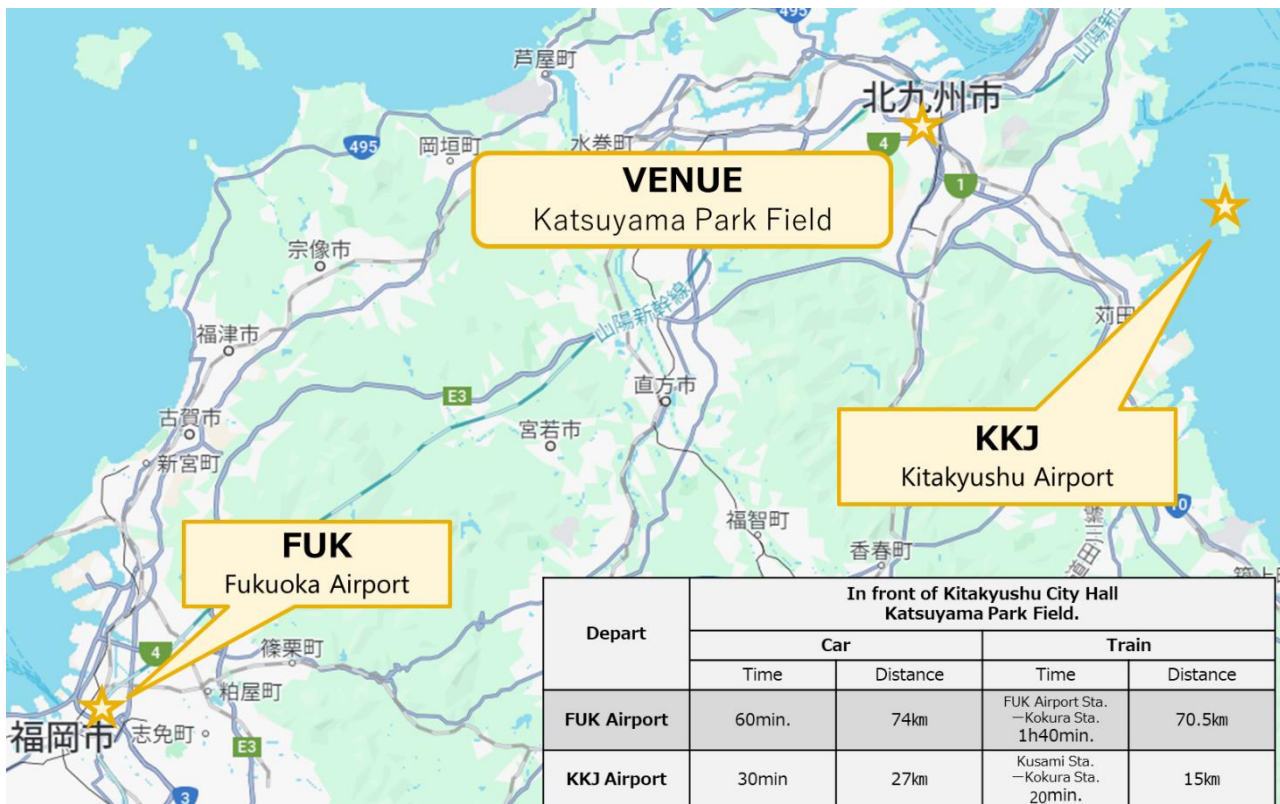

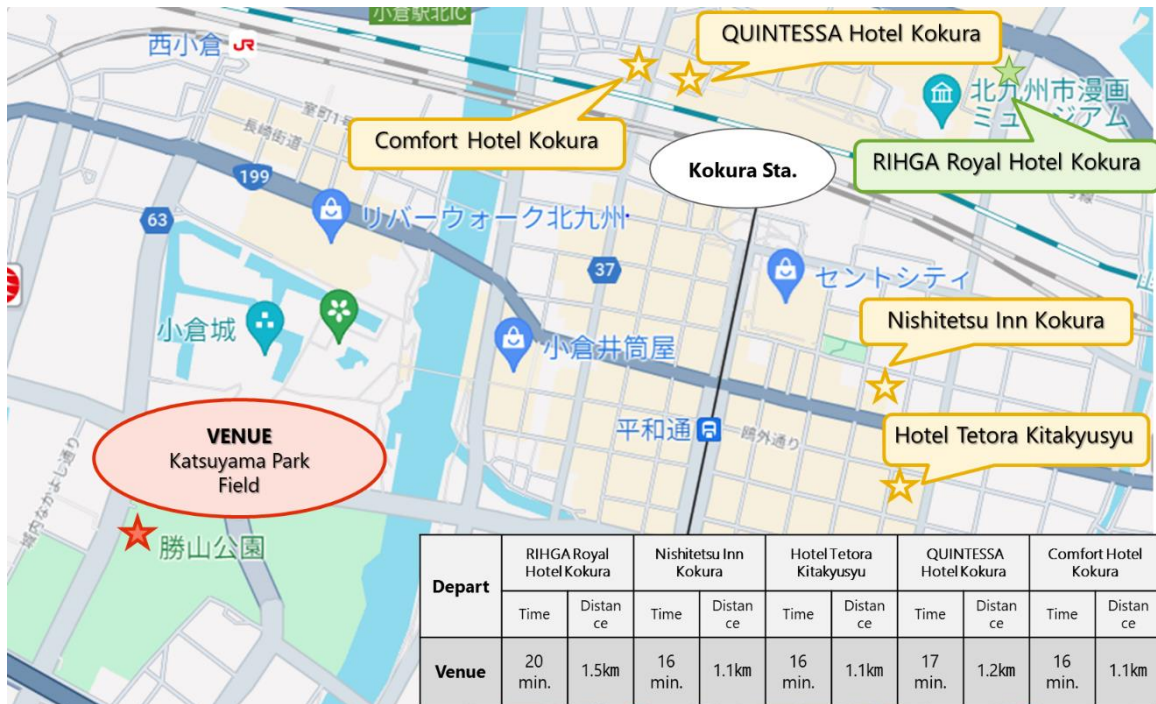

20. INSURANCE

The Host Federation, the LOC and the FIG will not be held responsible for any liabilities in case of accidents, illness (including COVID-19), repatriation and the like.

The FIG Technical Regulations foresee that all participating Federations are responsible for making their own arrangements to have the necessary valid insurance coverage against illness, accidents and repatriation for all the members of their Delegation.

Basic insurance (sickness, accident and repatriation) in your country of residence is compulsory in order to be able to benefit from coverage by FIG IMSSA subsidiary insurance. Please also refer to <https://www.gymnastics.sport/site/pages/medical-insurance.php> for additional information regarding the FIG IMSSA insurance for Athletes and Judges.

If the note has not been sent in advance to the LOC (which is strongly recommended), the LOC will verify the insurance coverage upon arrival of the delegation members (e.g. cover note or photocopy of the valid policy).

The insurance must be valid at least starting from the arrival day of the delegation and must last for the delegations' entire stay

Delegation members with insufficient insurance coverage must inform the LOC. The LOC will subsequently offer insurance at the Federations' own charge. Further details can be obtained by contacting the LOC.

21. SPECIFIQUE RULES

General Rule for Juniors:

- The same Code of Points applies to both juniors and seniors, with specific additional restrictions for juniors to ensure safety.

Speed Discipline:

- **Jump Height Restriction:** Jumps of more than 2.5 meters are prohibited.

Freestyle Discipline:

- **Jump Height Restriction:** Jumps of more than 2.5 meters are prohibited.
- **Acrobatics Height Restriction:** Acrobatics performed at a height of more than 2 meters are prohibited. Any tricks performed above this height will not be scored.
- **Rotation Restriction:** Double rotations (i.e., flips or spins involving more than one complete rotation) are prohibited.
- **Twist Restriction:** More than one twist (i.e., more than 360 degrees of rotation around the vertical axis) in any trick is prohibited.

22. WORK PLAN

The Work Plan will be published on the FIG online calendar four weeks at the latest before the start of the competitions.

23. SAFEGUARDING AND PROTECTING PARTICIPANTS IN GYMNASTICS

From the official date of arrival until the official day of departure of the event, participants (athletes, coaches, judges and any other delegation members) have the opportunity to contact by phone or e-mail the LOC Safeguarding Officer in case of harassment or abuse of any type or if they are worried or do not feel comfortable.

The information regarding the LOC Safeguarding Officer will be communicated upon arrival of the delegations.

24. DOPING CONTROLS

Anti-doping controls will be organised by the International Testing Agency (ITA) on behalf of the FIG and according to the WADA Code, Standards and FIG Anti-Doping Rules.
