The FIG is pleased to herein provide you with the Directives for the 2nd FIG Parkour World Championships to be held in Kitakyushu (JPN) from 15-17 November 2024.

These World Championships will be organized following the FIG Statutes, the 2024 Technical Regulations, the 2024 PK Code of Points as well as FIG Framework for Safeguarding Athletes and other Participants from Harassment and Abuse in Sport during Events, and all other Rules, Regulations and Guidelines valid, any possible amendments by the date of these WCH, and any additions decided in the interim.

All participating Federations commit to abide by the Statutes and all FIG Rules and Regulations. National Federations not respecting them will not be allowed to participate.

## 5. PARTICIPATION AND ACCREDITATIONS

---

All NFs in good standing are entitled to participate with a full quota of max. 8 men and 8 women.

The size of delegation is as follows.

Athletes can participate in both events provided that the maximum athlete quota place per event (max.4) is not exceeded.

## 6. COACHES

---

To be registered on the competition every coach should have a coach-sport profile in the FIG database (please see FIG official communication of 31 March 2021). No coach will be accepted without a valid coach-sport profile at the deadline of the Nominative Registration.

In order to be considered, the coach-sport profile (including the documents) must be submitted at least two (2) weeks prior to the deadline for nominative registration.

Only registered coaches can access the Field of Play during training.

## 7. AGE LIMITS

---

Minimum 17 years old in the year of the competition (born in 2007 or before)

## 8. LICENSES

---

No Athletes will be accepted without a valid FIG License (at the date of the Nominative Registrations).

## 9. JUDGES AND JURY OF APPEAL

---

### **Judges**

Each Judges' Panel consists of:

Speed: 1 Chair of Judges' Panel (CJP), 1 Start Line and 2 Time Judge (ST/T), 4 check-point or line judges (CP/L)

Speed judges are drawn from the list of FIG Parkour judges from the participating federations and FIG nominated judges, with the CJP directing their work. Any open judge positions will be nominated by FIG.

Freestyle: 8 judges (3 per Difficulty and 3 per Execution) will judge, including one Difficulty judge who is also acting as CJP. 2 Line Judges can be used.

Difficulty judges are nominated and invited by the FIG. Execution judges are drawn from the participating federations on-site and attend at the expense of their NF.

### **Jury of Appeal and Supervisory Board**

For the composition of the Jury of Appeal, please consult the FIG Technical Regulations.

The Jury of Appeal will be decided in due time and listed in the Work Plan.

## 10. REGISTRATION DEADLINE

---

Registrations can only be made by FIG affiliated federations in good standing, via the **FIG** on-line system and by using the National Gymnastics Federations' login (e-mail) and password.

### **Definitive Registration**

The definitive registrations must be completed by entering the composition of the delegation by 23:59 CET (Swiss Time) on Wednesday, 18 September 2024 at the very latest.

## Nominative Registration

The nominative entries must be completed by entering the composition of the delegation by 23:59 CET (Swiss Time) on Wednesday, 16 October 2024 at the very latest.

Together with the nominative registration and to accelerate the process of the accreditation, the delegations must send one passport photo of each delegation member to [jkoslacz@fig-gymnastics.org](mailto:jkoslacz@fig-gymnastics.org).

Requirements for each identity colour photo:

- File format: .jpg or .jpeg
- Dimensions: min. 175 X 225 pixels, max. 1750 X 2250 pixels (width X height)

Accreditations sent without photos will not be handled with priority. You may have to wait at the accreditation desk upon arrival.

After the drawing of lots, no athlete can be added. No additional athlete may appear on the Nominative Registration or at accreditation.





## 21. INSURANCE

---

The Host Federation, the LOC and the FIG will not be held responsible for any liabilities in case of accidents, illness (including COVID-19), repatriation and the like.

The FIG Technical Regulations foresee that all participating Federations are responsible for making their own arrangements to have the necessary valid insurance coverage against illness, accidents and repatriation for all the members of their Delegation.

Basic insurance (sickness, accident and repatriation) in your country of residence is compulsory in order to be able to benefit from coverage by FIG IMSSA subsidiary insurance. If the note has not been sent in advance to the LOC (which is strongly recommended), the LOC will verify the insurance coverage upon arrival of the delegation members (e.g. cover note or photocopy of the valid policy).

The insurance must be valid at least starting from the arrival day of the delegation and must last for the delegations' entire stay

## 22. THE WORLD GAMES 2025- CHENGDU (CHN)

## 23. WORK PLAN

## 24. SAFEGUARDING AND PROTECTING PARTICIPANTS IN GYMNASTICS

---

From the official date of arrival until the official day of departure of the event, participants (athletes, coaches, judges and any other delegation members) have the opportunity to contact by phone or e-mail the LOC Safeguarding Officer in case of harassment or abuse of any type or if they are worried or do not feel comfortable.

The information regarding the LOC Safeguarding Officer will be communicated upon arrival of the delegations.

## 25. DOPING CONTROLS

---

Anti-doping controls will be organised by the International Testing Agency (ITA) on behalf of the FIG and according to the WADA Code, Standards and FIG Anti-Doping Rules.

## 26. ELECTIONS OF THE ATHLETES REPRESENTATIVE

---

The elections of the PK athletes' representative for 2025 until 2028 will take place as follows:

- **14 November 2024**

This election will be made according to the Art 21, of the FIG Statutes and based on the candidatures received.

Not more than one representative in the FIG athletes' commission per Federation will be allowed. The assembly of the athletes will be open to two athletes per member federation. The election will be directed by a person to be designated at a later stage, accompanied respectively by the President of the PK commission.

Candidates must be proposed by their National Gymnastics Federation as soon as possible, but by no later than **14 August 2024**.

Candidatures must be accompanied by a CV (curriculum vitae), a motivation letter and a written confirmation whereas the federation will be responsible for the full costs of travel and lodging involved in attendance at meetings (including the expenses of any interpreters) should the FIG be unable to offer any direct assistance in this regard. An assurance must also be given that the candidate, if elected, will be provided with administrative support if required, and every facility to enable him/her to attend meetings.

The FIG and its Athletes' Representative for Parkour, Ms. Micaela Buono Pugh, invite athletes from all participating Federations to the Athletes' meeting following this election.
