JUDGES AND JURIES	All judges must have a current valid FIG brevet at the time of the event, for the respective discipline (RGI/RGG).

ENTRY FEES	<p>The non-refundable Entry fee for this event will be as follows:</p> <ul style="list-style-type: none"> - 50 EUR per RGI gymnasts; - 150 EUR per Group; - 100 EUR per person (incl. gymnasts, coaches and staff), who have not booked their accommodation and meals through LOC. 	
ACCREDITATION	<p>The accreditation procedure will take place at the competition hall. <u>Heads of delegation must keep the accreditation schedule, which will be distributed by LOC before the official date of arrival.</u></p> <p>Heads of delegation have to bring to the accreditation office:</p> <ul style="list-style-type: none"> • passports of all participants • national anthem • national flag • 1 USB per music routine – the file should be named correctly – XXX(country code)_XXXXXXX(gymnast last name)_XXXXXX(routine) (for example: BUL_Kaleyn_Hoop) • Certification of insurance for all delegation members covering illness, accidents and repatriation – on paper, to be shown at accreditation. • Proof for full payment towards the LOC (copy of the SWIFT to be given to the LOC) • A declaration for use of personal data for all delegation members – on paper and signed by the HoD, or on email and signed and stamped by the NF. The declaration will be distributed in due time by LOC. <p>In addition, in order to receive accreditation, music form must be filled out and sent online by 27 February 2025.</p> <p>In addition, the LOC will distribute information regarding the gymnasts' safeguarding plan.</p>

VISA	<p>Please verify immediately with your travel agent or the Bulgarian Embassy or Consulate in your country if a visa is required for your travel to Bulgaria. The LOC will be happy to assist each Delegation member with an official invitation letter, provided that the request is made before 27 January 2025 to the LOC.</p> <p>IMPORTANT: In case your team member need visa in order to enter Bulgaria, you should inform LOC via email ONLY at bulrg_office@fbgr.org. LOC will then send the correct form to be filled out</p> <p>Note: Bulgaria applies a visa-free system for holders of valid Schengen visas.</p>
INSURANCE	<p>The Host Federation, the LOC and the FIG will not be held responsible for any liabilities in case of accidents, illness (including COVID-19), repatriation and the like.</p> <p>The FIG Technical Regulations foresee that all participating Federations are responsible for making their own arrangements to have the necessary valid insurance coverage against illness, accidents and repatriation for all the members of their Delegation.</p> <p>Basic insurance (sickness, accident and repatriation) in your country of residence is compulsory in order to be able to benefit from coverage by FIG IMSSA subsidiary insurance. Please also refer to https://www.gymnastics.sport/site/pages/medical-insurance.php for additional information regarding the FIG IMSSA insurance for Athletes and Judges. The LOC will verify the insurance coverage upon arrival of the delegation members (e.g. cover note or photocopy of the valid policy). The insurance must be valid at least starting from the arrival day of the delegation and must last for the delegations' entire stay</p> <p>The LOC will subsequently offer insurance at the Federations own charge as follows: 25 EUR per person/day.</p>
SAFEGUARDING	<p>From the official event day of arrival until the official day of departure, participants (gymnasts, coaches, judges and any other delegation members) have the possibility to contact by phone or e-mail the LOC Safeguarding Officer in case of harassment and abuse of any type or if they are worried and do not feel comfortable.</p> <p>The information regarding the LOC Safeguarding Officer will be communicated upon arrival of the delegations on site.</p> <p>In addition, posters of the "10 Golden Rules of Gymnastics", the FIG campaign to raise awareness about youth protection in Gymnastics, will have to be displayed in several locations, including training and warm-up halls and public zones.</p>

INTERNATIONAL TRANSPORTATION	<p>The invited participating federations must pay for the travel costs of their delegation members.</p> <p>The Travel Schedule Form must be returned to the LOC by 27 February 2027 at the latest.</p>
LOCAL TRANSPORTATION	<p>The LOC will arrange the local transportation (i.e. from/to the airport, railway station and/or bus station as well as from/to the hotel and the Venue) to all participating NFs, who have booked their accommodation and meals through LOC.</p> <p>The local transport is ensured from the official day of arrival to the official day of departure.</p>
ACCOMMODATION	<p>The invited participating federations must pay for the accommodation expenses of their delegation members.
