

The LOC will be happy to assist each Delegation member with an official invitation letter, provided that the request is made before <b>01.03.2025</b> to the LOC.</p> <p>The request must include the function, full name, gender, date of birth, citizenship and passport number, passport expiry date, the arrival and departure dates of the Delegation Member as well as the city the visa application support letter must be sent to.</p>
<b>INSURANCE</b>	<p>Federations are responsible for making their own arrangements to have the necessary valid insurance coverage against illness (including COVID-19), accidents and for repatriation for all the members of their delegation.</p> <p>Basic insurance (sickness, accident and repatriation) in your country of residence is compulsory in order to be able to benefit from coverage by FIG IMSSA subsidiary insurance. <b>SAFEGUARDING</b>	<p>From the official day of arrival to the official day of departure, participants (gymnasts, coaches, judges and other members of the delegation) have the opportunity to contact the LOC Security Officer by phone or email if any type of harassment and abuse occurs or if they are concerned and do not feel comfortable.</p> <p>Information regarding the LOC Security Inspector will be provided after the delegation arrives on site.</p> <p>In addition, posters of "10 Golden Rules of Gymnastics", FIG's campaign to raise awareness of the protection of youth practicing gymnastics, will be required to be</p>
