<b>PARTICIPATION</b>	<p>The World Cup competition will consist of Qualifications and Finals.</p> <p><b>Participation in the Qualifications:</b></p> <ul style="list-style-type: none"> <li>• All competitors must take part in the qualifications.</li> <li>• In case of a tie at any place, the tie-breaking rules as set up for the World Championships shall be applied. Nevertheless, the gymnasts not qualified for the finals and with the same final score will receive the same world cup points.</li> </ul> <p><b>Participation in the Finals:</b></p> <ul style="list-style-type: none"> <li>• The top eight gymnasts or pairs from the qualifications qualify for the finals.</li> <li>• Max. 2 individuals or 1 pair per NF per discipline.</li> <li>• In case of a tie at any place, the tie-breaking rules as set up for the World Championships shall be applied.</li> <li>• If there are less than 4 countries registered in a category after the definitive deadline, no medals, prize money and World Cup points will be awarded.</li> </ul>	
<b>FEDERATIONS INVITED</b>	The Organizing Member Federation invites all FIG Member Federations who have paid their annual membership fee for Trampoline Gymnastics.	
<b>SIZE OF DELEGATION AND FIG LICENCE</b>	Only senior gymnasts in good standing with the correct age and holding a valid FIG License may participate. The maximum size of each delegation is as per FIG Rules for Accreditation.	
<b>AGE LIMITS</b>	Participating gymnasts must be at least 17 years (born in 2008 or before) in all disciplines.	
<b>JUDGES AND JURIES</b>	<p>The number of Judges' panels may be decided by the organizing member federation depending on the number of participating competitors and judges. The Judges' panels will be set up by a draw – directed by the FIG Technical Delegate – from the judges present at the event.</p> <p>Each participating federation must provide minimum one judge per discipline in which they participate, according to the requirements in force. Failure to do so will result in a fine of CHF 2'000.- to be paid to the organizing member federation for the cost of providing another judge.</p> <p>The organizing federation is responsible that there are enough FIG brevetted judges present with the appropriate category of brevet for their function.</p> <p>For categories and eligibility, please refer to the FIG General Judges Rules, Art 5.</p>	
<b>FIG TECHNICAL DELEGATE AND EC MEMBER</b>	<p>The FIG Technical Delegate and EC member (if applicable) will be designated by the FIG.</p> <p>The FIG Technical Delegate will serve as President of the Superior Jury.</p>

<b>DRAWING OF LOTS</b>	<p>The drawing of lots will take place at the FIG Headquarters in Lausanne (SUI) two weeks after the closing date of the nominative registration.</p>															
<b>ENTRY FEES</b>	<p>The cost for the entry fee is <b>125 EUR</b> per gymnast.</p> <p>The invited participating federations must pay for all entry fees. At the time of the Definitive registration (2 months prior to the event) 100% of the entry fee must be paid to the LOC. The entry fee is not refundable.</p> <p><i>Exception is if because of low number of participants, the event is no longer a FIG World Cup.</i></p> <p>Entries without payment of the entry fees will be considered as invalid and will be refused.</p>

<b>FINAL BANQUET</b>	<p>The Final Banquet will be held on 21 September 2025 and will be free of charge for <b>all delegation members who booked their accommodation through the LOC</b>.</p> <p>Every delegation will receive an invitation once all financial issues between the LOC and the delegation are duly solved.</p> <p><b>The tickets for the Final Banquet will be 75 € per Person for delegations who have not booked through the LOC and must be paid to the LOC 22 August 2025.</b></p>
<b>INTERNATIONAL TRANSPORTATION</b>	<p>The invited participating federations must pay for the travel costs of their delegation members.</p> <p>The Travel Schedule information must be submitted to the LOC by <b>22 August 2025</b>.</p>
<b>LOCAL TRANSPORTATION</b>	<p>The local transportation from the airports Berlin (BER) and Dresden (DRS) and between the hotel and the venue will be provided <b>at no extra cost for delegations who have booked through the local organizer Cat. 1 &amp; 2</b>.</p> <p><b>For delegation who have booked other options, the costs of 60 € (per delegation member) for the local transportation must be paid to the LOC by 22 August 2025.</b></p>
<b>VISA</b>	<p>Please verify immediately with your travel agent or the German Embassy or Consulate in your country if a visa is required for your travel to Germany. The Organizing Committee will be happy to assist each Delegation member with an official invitation letter, provided that the request is made before <b>22 August 2025</b> to the LOC.</p> <p>The request must include the function, full name, gender, date of birth, citizenship and passport number, passport expiry date, the arrival and departure dates of the Delegation Member as well as the city the visa application support letter must be sent to.</p>
<b>INSURANCE</b>	<p>The Host Federation, the LOC and the FIG will not be held responsible for any liabilities in case of accidents, illness (including viruses), repatriation and the like. The FIG Technical Regulations foresee that all participating Federations are responsible for making their own arrangements to have the necessary valid insurance coverage against illness, accidents and repatriation for all the members of their Delegation.</p> <p>Basic insurance (sickness, accident and repatriation) in your country of residence is compulsory in order to be able to benefit from coverage by FIG IMSSA subsidiary insurance.</p> <p>Please also refer to</p>

<b>ACCREDITATION</b>	<p>Accreditation will be distributed at the Lausitz Arena.</p> <p>Accreditation cards will be distributed at the Accreditation desk situated at the Competition Venue upon arrival of the delegations. The following items will be checked there with the Heads of delegations:</p> <ul style="list-style-type: none"> <li>• Passport, Names and date of birth of all members of the delegations</li> <li>• Total payment of costs due to the LOC and / or the FIG</li> <li>• Flight schedule</li> <li>• The mandatory insurance for all the delegation's members</li> <li>• 2 copies of competition cards for each gymnast/synchro pair</li> <li>• National anthem and national flag</li> </ul> <p>In addition, the LOC will distribute information regarding the safeguarding Officer operations plan upon accreditation.</p>
<b>FINANCIAL OBLIGATIONS</b>	<p>Federations which have not fulfilled their financial obligations towards the FIG (e.g. annual membership fees, unpaid invoices, etc.) or the LOC may not be allowed to participate in these World Cups.</p> <p>Federations which have not fulfilled their financial obligations towards the LOC by the given deadline in the Invitation/Directives, may still have the possibility to participate, but the LOC will not guarantee the hotel booking, meals and local transportation.</p>

<b>CANCELATION POLICY</b>	<p>The whole amount will be refunded for cancellations by the federations submitted before <b>18 July 2025</b>. For any partial or total cancellation after <b>18 July 2025</b> by the federations, no money will be refunded. <b>If accommodation and other services are booked after the respective deadlines, the amount is due immediately and no money is refunded in case of a cancellation by the federations.</b></p> <p><b>If the event has to be cancelled due to force majeure, the LOC will try to provide a refund of the costs but the financial responsibility for all costs</b></p>

<b>TIE BREAKING RULES</b>	<p>In case of a tie at any place, the tie-breaking rules as set up for the World Championships shall be applied.</p> <p>The gymnasts with same final score will receive the same World Cup points.</p> <p>If there is still a tie, the points of the respective ranking are added and divided by the number of tied gymnasts / pairs.</p> <p>Example:</p> <p>1, 1, 3 (points for rank 1 and 2 is added and divided by 2)  1, 2, 2, (points for rank 2 and 3 is added and divided by 2)</p> <p>The same principle applies to the prize money.</p>																																				
<b>PRIZE MONEY (exchange rate subject to change)</b>	<p>The organising member federation will pay the following minimum prize money per discipline - "discipline" means every final: individual trampoline women, individual trampoline men, synchro women, synchro men, synchro mixed (tbd). <b>ASSIGNMENT OF WORLD CUP SERIES RANKING POINTS</b>	<p>In principle, the official results and the updated FIG World Cup Series Ranking List will be published on the FIG web site within one working day after the competition.</p> <p>Separate World Cup Series Ranking Lists are established for every discipline, beginning with the first World Cup event of the year and ending with the last World Cup event of the year as follows:</p> <ul style="list-style-type: none"> <li>• Trampoline Individual Men / Trampoline Individual Women</li> <li>• Trampoline Synchro Men / Trampoline Synchro Women</li> </ul> <p>For individual Trampoline, World Cup points are assigned to the competitors by name.</p> <p>Trampoline Synchro pairs are listed by name but considered as an entity. A) in which the World Cup winner will receive the World Cup.

<b>MEDICAL</b>	The medical care will be fully guaranteed by the Organising Committee. The guarantee includes first aid as well as an ambulation in a nearby hospital. There will be a doctor available during the event and will provide assistance to all competing Federations. A paramedic ambulance will be on site during official training, warm up and competition periods.

<b>ANTI-DOPING</b>	<p><b>Doping Controls</b> Doping controls will be organised by the International Testing Agency (ITA) on behalf of the FIG and according to the WADA Code, Standards and FIG Anti-Doping Rules.</p> <p><b>Host federation WADC compliance</b> The exploitation of any rights related to the hosting of an event is subject, at all times, to the compliance with the WADC and the international standards enacted by WADA. Regardless of whether the event has already been allocated or not, the FIG may terminate any collaboration with the host federation or the LOC, immediately and without paying any penalty and/or compensation or incurring liability of any kind, under the following circumstances:</p>

	<p>i if the National Anti-Doping Organisation (NADO) in charge in the concerned country is declared non-compliant by WADA  ii if the relevant country has been ruled ineligible to host the event.</p> <p>In such cases, the FIG is entitled to reassign the event to any other host federation in another country where the WADC and the WADA international standards are fully respected.</p>
<b>SAFEGUARDING</b>	<p>From the official date of arrival until the official day of departure of the event, participants (gymnasts, coaches, judges and any other delegation members) have the opportunity to contact by phone or e-mail the LOC Safeguarding Officer in case of harassment or abuse of any type or if they are worried or do not feel comfortable.</p> <p>The information regarding the LOC Safeguarding Officer will be communicated upon arrival of the delegations.</p> <p>In addition, posters of the “10 Golden Rules of Gymnastics”, the FIG campaign to raise awareness about youth protection in Gymnastics, will have to be displayed in several locations, including training and warm-up halls and public zones.</p>
<b>MARKETING</b>	<p>The FIG advertising and publicity norms will be respected.</p>
<b>TELEVISION</b>	<p>The Organizing Member Federation will guarantee the production of a basic feed (international signal) at least for the Final rounds. Television Broadcast information will be released at a later time.</p>
<b>VIDEO CONTROL SYSTEM</b>	<p>Should IRCOS not be available, the Organizing Member Federation must provide another video control system which allows to treat inquiries and records all exercises of the competition in a quality which allows to judge the exercises.</p>
