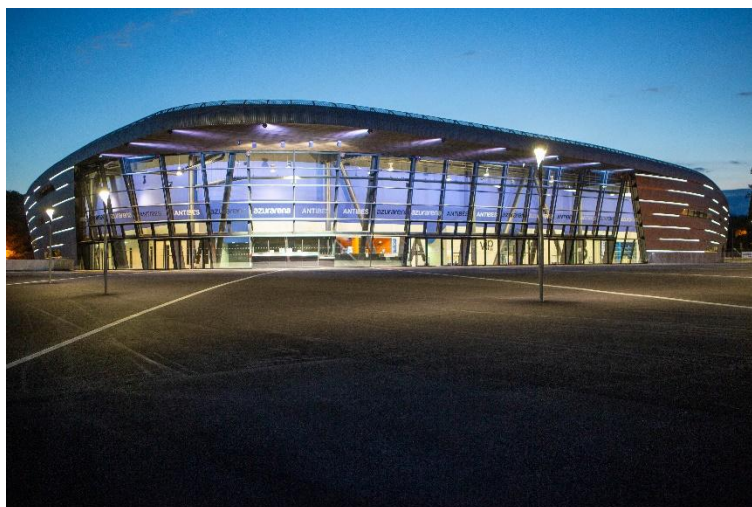

| VENUE | Azur Arena Antibes 250 rue Emile Hugues 06600 Antibes, France Ideally located in Antibes Juan-les-Pins, 20-minutes away from Cannes and Nice, close from Sophia-Antipolis, the first European Technopole, AzurArena is 13.600 m ² multisport complex. It is easily reachable thanks to its localisation of the Bus-Tram way, its proximity with Nice Côte d'Azur International Airport (20 mn) and highway exit of Antibes (1 km). The main area of the AzurArena can host up to 5.000 spectators in its biggest configuration (4.000 for the TR/TU World Cup-configuration). Beside from the main Arena, a 1.000 m ² space is dedicated to Trampoline and Acrobatic Gymnastics, as it is the permanent training site for the Trampoline high-level |

performance athletes and for the organising club for Trampoline and Acrobatic Gymnastics.

PARTICIPATION

The World Cup competition will consist of Qualifications and Finals.

Participation in the Qualifications:

- All competitors must take part in the qualifications.
- In case of a tie at any place, the tie-breaking rules as set up for the World Championships shall be applied. Nevertheless, the gymnasts not qualified for the finals and with the same final score will receive the same world cup points.

| | <p>Participation in the Finals:</p> <ul style="list-style-type: none">• The top eight gymnasts or pairs from the qualifications qualify for the finals.• Max. 2 individuals or 1 pair per NF per discipline.• In case of a tie at any place, the tie-breaking rules as set up for the World Championships shall be applied.• If there are less than 4 countries registered in a category after the definitive deadline, no medals, prize money and World Cup points will be awarded. <p>Cancellation Policy (valid for TUM only):</p> <p>The organizing member Federation (LOC) may cancel the competition if at the time of the definitive entry there are less than 4 countries registered in this category after the definitive deadline. In case of such a cancellation, the LOC must reimburse, in full, the entry fee and payments made for accommodation. Should flights have to be cancelled due to the above, the risk is at the charge of the participating member Federations (NF).</p> <p>The participating member Federation (NF) may cancel its participation without any penalty or payment for fees, accommodation and meals already booked, in case of less than 4 countries registered in that category after the definitive deadline.
