ACCREDITATION	<p>Accreditation will take place MSC (Competition Hall), before the official training. MEDICAL SERVICES	Medical service in the gym will be provided by LOC
VISA	<p>Please verify immediately with your travel agent or the Montenegrin Embassy or Consulate in your country if a visa is required for your travel to Montenegro. The LOC will be happy to assist each Delegation member with an official invitation letter, provided that the request is made before September 30th to the LOC.</p> <p>The request must include the function, full name, gender, date of birth, citizenship and passport number, passport expiry date, the arrival and departure dates of the Delegation Member as well as the city the visa application support letter must be sent to.</p>
INSURANCE	<p>The Host Federation, the LOC and the FIG will not be held responsible for any liabilities in case of accidents, illness, repatriation and the like.</p> <p>The FIG Technical Regulations foresee that all participating Federations are responsible for making their own arrangements to have the necessary valid insurance coverage against illness, accidents and for repatriation for all the members of their Delegation.</p> <p>Basic insurance (sickness, accident, and repatriation) in your country of residence is compulsory in order to be able to benefit from coverage by FIG IMSSA subsidiary insurance. Please also refer to https://www.gymnastics.sport/site/pages/medical-insurance.php for additional information regarding the FIG IMSSA insurance for Athletes and Judges</p> <p>The LOC will verify the insurance upon arrival of the delegation members (e.g. cover note or photocopy of the valid policy). Delegation members with insufficient insurance cover must inform the LOC in advance.</p> <p>The LOC will subsequently offer insurance at the Federations own charge as follows: 25€ per person/day.</p>
SAFEGUARDING	<p>From the official event day of arrival until the official day of departure, participants (gymnasts, coaches, judges and any other delegation members) have the possibility to contact by phone or e-mail the LOC Safeguarding Officer in case of harassment and abuse of any type or if they are worried and do not feel comfortable.</p> <p>The information regarding the LOC Safeguarding Officer will be communicated upon arrival of the delegations on site.</p> <p>In addition, posters of the “10 Golden Rules of Gymnastics”, the FIG campaign to raise awareness about youth protection in Gymnastics, will have to be displayed in several locations, including training and warm-up halls and public zones.</p>

	<p>The invited participating federations or clubs must pay for accommodation and meals expenses of their delegation members.</p> <p>The prices charged for the hotel rooms will not exceed the usual hotel rates. While the Accommodation Form must be uploaded by September 30th at the very latest, the costs for the accommodations must be paid to the LOC as follows:</p> <ul style="list-style-type: none"> - at the time of the Definitive Entry (September 30th) 50% of the accommodation costs. - at the time of the Nominative Entry (October 30th) the remaining 100% of the accommodation costs. <p>Cancellation/Reimbursement Policy: 30% of the total accommodation costs are refundable in case of cancellations at least 1 month prior to the event (October 20th)</p> <p>For cancelations made after October 20th there will be no reimbursement.</p>																
MEALS	<p>All the delegation members who booked their accommodation through the LOC will have all meals included in the accommodation price.</p> <p>Breakfast and Dinner will be served at the hotel, except the lunch for judges, who will be served in the Competition Venue, during the competition days.</p>
