AGE LIMITS	<p><b>WAG:</b> Junior* As per FIG technical regulations <b>MAG:</b> Junior* As per FIG technical regulations (18 years old MAG gymnasts who chose to compete as seniors in 2025 are not allowed to participate in this competition). <i>*Ages as of December 31, 2025</i> <b>All gymnasts must have a valid FIG license until the end of the event.</b></p>														
JUDGES AND JURIES	<p><b>All judges must have a current valid FIG brevet at the time of the event, for the respective discipline.</b> Each Federation must register 1 judge if participates with 1-2 gymnasts (individuals) and 2 judges if participates with 3-5 gymnasts (teams). The Federations can register a second judge (for individuals) or a third judge (for teams), different from the CONSUGI TC Member as additional accredited person, with no cost for this accreditation. Provision of max. 1 judge per NF per panel. The fine for not registering the required number of judges in each discipline is <b>USD\$1,200.00</b> per missing judge. The Federations with a CONSUGI TC Member can register that Member in addition to their official judges. The fines for not registering the required number of judges must be paid to CONSUGI by <b>September 04<sup>th</sup>, 2025</b> at the latest and it does not apply to those Federations that do not have FIG brevet judges in the respective discipline (MAG, WAG) and that this is the first cycle in which they participate in CONSUGI competitions. The National Federation must inform CONSUGI at the time of the definitive registration (<b>September 04<sup>th</sup>, 2025</b>) to allow the appointment of invited neutral judges.</p>
