<b>JUDGES</b>	<b>All judges must have a valid FIG brevet in the respective discipline (RGI and/or RGG).</b>
<b>COMPETITIONS HEAD JUDGE</b>	The President of the Superior Jury will be shortly advised, Minimum cat 2.
<b>SIZE OF THE DELEGATIONS</b>	<p>Each delegation may consist:</p> <ul style="list-style-type: none"> <li>* Gymnasts according to the regulations of GP.</li> <li>* 1 coach</li> <li>* 1 judge. <b>In case a delegation is not able to bring a judge, that delegation must cover the accommodation costs of a person.</b></li> </ul>

<b>VISA</b>	<p>Please verify immediately with your travel agent or the Spanish (complete) Embassy or Consulate in your country if a visa is required for your travel to Spain.</p> <p>The LOC will be happy to assist each Delegation member with an official invitation letter, provided that the request is made before <b>18 February 2026</b> to the LOC.</p> <p>To request an invitation letter, please send the following information to the LOC: Full Name, Gender, Date of Birth, Citizenship, Passport Number, Passport Expiry Date, Function/Role within the Delegation, Arrival and Departure Dates, City where the visa application support letter should be sent.</p> <p>Please ensure that all information is complete and accurate to avoid delays in</p>

	visa processing.

<b>SAFEGUARDING</b>	<p>From the <b>official day of arrival</b> until the <b>official day of departure</b>, all participants — including <b>gymnasts, coaches, judges, and other Delegation Members</b> — will have the possibility to <b>contact the LOC Safeguarding Officer</b> by phone or email in case of:</p> <ul style="list-style-type: none"> <li>• Harassment</li> <li>• Abuse of any kind</li> <li>• Any situation where they feel uncomfortable or unsafe</li> </ul> <p>The <b>contact information</b> for the LOC Safeguarding Officer will be <b>provided to all Delegations upon arrival</b> on site.</p> <p>As part of the FIG's commitment to athlete welfare and youth protection, <b>posters of the “10 Golden Rules of Gymnastics”</b>, part of the FIG's awareness campaign, must be <b>clearly displayed</b> in several key areas, including:</p> <ul style="list-style-type: none"> <li>• Training Halls</li> <li>• Warm-Up Areas</li> <li>• Public Zones</li> </ul> <p>These measures are in place to ensure a <b>safe, respectful, and supportive environment</b> for all participants throughout the event.</p>
<b>INTERNATIONAL TRANSPORT</b>	<p>The Organizing Committee will offer to the members of delegations a free service of transport from / to Malaga Airport or to Maria Zambrano Station, as well as from the official hotel to venue of the competition (and vice versa). The Travel Form must filled in via website <b>before March 7<sup>th</sup> 2026</b></p>
<b>LOCAL TRANSPORT</b>	<p>The Organizing Committee will offer to the participants free transport from the official hotel to the venue of the competition (and vice versa).</p>
