PARTICIPANTS	The Organizing Member Federation will invite all Member Federations in good standing.

	Delegation will consist of 1-2 Senior and (or) 1-2 junior individual gymnasts. Please note that it is possible to participate with maximum 2 seniors and (or) maximum 2 juniors per country (except of NF).
AGE	Junior & Senior, as per FIG Technical Regulations . All gymnasts must have an FIG licence valid until the end of the event.
JUDGES	All judges must have a current valid FIG brevet at the time of the event. If a Federation does not enter a judge or comes with a judge of an insufficient level, LOC will request the payment of a fine of 200 EUR per missing judge.
ENTRY FEES	The entry fee for this event will be: 75 EUR per each individual gymnast. The entry fee is non-refundable.
ACCREDITATION	Delegations must present (if not sent by email previously): <ul style="list-style-type: none"> • Passports/ID cards of gymnasts • Insurance for all members of delegations • FIG licenses for gymnasts and judges • Music for all exercises of gymnasts (USB) • Receipt of payment of start fee, accommodation (if applicable). In addition, the LOC will distribute information regarding the gymnasts' safeguarding plan.

APPARATUS FINAL – Finals (the best 8 gymnasts per apparatus – max 2 per federation). In addition, if not qualified, the NF may participate in the four finals with more gymnasts, at its free choice.</p>

VISA	Please verify immediately with your travel agent or the Luxembourgish Embassy or Consulate in your country if a visa is required for your travel to Luxembourg. The Organizing Committee will be happy to assist each Delegation member with an official invitation letter, if the request is made before 15.12.2025 to the LOC. To request an invitation letter, please send the following information to the LOC: Full Name, Gender, Date of Birth, Citizenship, Passport Number, Passport Expiry Date, Function/Role within the Delegation, Arrival and Departure Dates, City where the visa application support letter should be sent.

LOCAL TRANSPORTATION	<p>The LOC will provide the transfer from Luxembourg airport (40 km)/from Luxembourg Gare (30 km) to the hotel and from the hotel to the hall (and vice – versa).</p>
