Federations which have not fulfilled their financial obligations towards the Organizing Member federations upon arrival will not be accredited.																																								
<b>PARTICIPATION AND FIG LICENCE</b>	<p>Only senior gymnasts in good standing with the correct age and holding a valid FIG License may participate. The Organizing Committee will be responsible for checking the validity of the gymnasts' licenses. No gymnasts will be accepted without a valid FIG License at the deadline of the Nominative Registration. <b>DRAWING OF LOTS/REPLACEMENT POLICY</b>	<p>The gymnasts' drawing of lots for all FIG Apparatus World Cup events will be managed electronically.</p> <p>If not possible, it will take place on site, during the orientation meeting or during a separate function organized for that purpose with invitation to all participating NFs. <b>ANTI-DOPING</b>	<p><b><u>Doping controls</u></b> Doping controls will be organized by the International Testing Agency (ITA) on behalf of the FIG and according to the World Anti-Doping Code (WADC), the international standards enacted by the World Anti-doping Agency (WADA) and FIG Anti-Doping Rules.</p> <p><b><u>Host federation WADC compliance</u></b> The exploitation of any rights related to the hosting of an event is subject, at all times, to the compliance with the WADC and the international standards enacted by WADA. Regardless of whether the event has already been allocated or not, the FIG may terminate any collaboration with the host federation or the LOC, immediately and without paying any penalty and/or compensation or incurring liability of any kind, under the following circumstances:</p>

	<p>(i) if the National Anti-Doping Organisation (NADO) in charge in the concerned country is declared non-compliant by WADA</p> <p>(ii) if the relevant country has been ruled ineligible to host the event.</p> <p>In such cases, the FIG is entitled to reassign the event to any other host federation in another country where the WADC and the WADA international standards are fully respected.</p>
<b>VISA</b>	<p>Please verify immediately with your travel agent or the <b>Egyptian</b> Embassy or Consulate in your country if a visa is required for your travel to <b>Egypt</b>. The Organizing Committee will be happy to assist each Delegation member with an official invitation letter, provided that the request is made before <b>01 February 2026</b> to the LOC.</p> <p>The request must include the function, full name, gender, date of birth, citizenship and passport number, passport expiry date, the arrival and departure dates of the Delegation Member as well as the city the visa application support letter must be sent to.</p>
<b>INSURANCE</b>	<p>The Host Federation, the LOC and the FIG will not be held responsible for any liabilities in case of accidents, illness (including COVID-19), repatriation and the like.</p> <p>The FIG Technical Regulations foresee that all participating Federations are responsible for making their own arrangements to have the necessary valid insurance coverage against illness, accidents and repatriation for all the members of their Delegation.</p> <p>Please also refer to <a href="https://www.gymnastics.sport/site/pages/medical-insurance.php">https://www.gymnastics.sport/site/pages/medical-insurance.php</a> for additional information regarding the FIG IMSSA insurance for Athletes and Judges.</p> <p>If the note has not been sent in advance to the LOC (which is strongly recommended), the LOC will verify the insurance coverage upon arrival of the delegation members (e.g. cover note or photocopy of the valid policy).</p> <p>The insurance must be valid at least starting from the arrival day of the delegation and must last for the delegations' entire stay</p> <p>Delegation members with insufficient insurance coverage must inform the LOC in advance. The LOC will subsequently offer insurance coverage at the Federations own charge as follows: <b>120 Euro</b> per person/day.</p>
<b>INTERNATIONAL TRANSPORTATION</b>	<p>The invited participating federations must pay for the travel costs of their delegation members.</p> <p>The Travel Schedule Form must be returned to the LOC by <b>01 March 2026</b>.</p>
<b>LOCAL TRANSPORTATION</b>	<p>The LOC will provide free local transportation for all participants, that book their accommodation through the LOC, from and to Cairo international airport as well as from/ to the hotel and competition, training and warm up hall.</p>

The remaining balance is due <b>by 1 March 2026</b>. <b>From 2 March 2026, no reimbursement will be made.</b></p> <p>The Organising Member Federation must pay for: Accommodation expenses, including full board, for the gymnasts ranked 1-3, per apparatus, as follows:</p> <ul style="list-style-type: none"> <li>• For the 2026, 2027 and 2028 Apparatus World Cup competitions the three best ranked Finalists per Apparatus from the last World Championships preceding the competition (including tied gymnasts if any).</li> </ul> <p>The Organising member Federation shall determine among the official hotels at its discretion, but may not chose the “low cost” category hotel.</p>
<p><b>FIG TECHNICAL DELEGATE AND EC MEMBER</b></p>	<p>The FIG Technical Delegate and EC member (if applicable) will be designated by the FIG.</p> <p>The FIG Technical Delegates will serve as Presidents of the Superior Jury.</p>
<p><b>WAG FX MUSIC</b></p>	<p>An online system, proposed by the FIG, will be used to download the floor music of all gymnasts, to provide information on the musical data and to help the NFs ensure that all music is correctly authorized for use in competition. Music Forms sent by email in .xls format will not be accepted.</p>
<p><b>JUDGES AND PANELS</b></p>	<p>Two Judges’ Panels for WAG and two or three for MAG, depending on the number of participants must be composed. Each Judges’ Panel must be composed as follows:</p> <ul style="list-style-type: none"> <li>– 2 D judges</li> <li>– 5 E judges</li> <li>– 1 Supervisor</li> </ul> <p><i>Note: for minimum category requirement, please refer to the FIG General Judges’ Rules</i></p> <p>Not more than one judge per Federation per panel will be permitted (except for Time and Line Judges).</p> <p>The Judges’ Panels are determined by a draw from the judges present at the event. The draw must be directed by the MAG and WAG Technical Delegates. The participating member federations must send minimum one qualified judge for MAG if they participate with male gymnasts and minimum one qualified judge for WAG if they participate with female gymnasts</p> <p>The Organizing Member Federation will apply a fine of <b>CHF 2’000</b> per missing judge (to be paid to the LOC) should a federation fail to bring the required number of judges. This fine must be paid to the LOC by <b>1 March 2026</b>.</p> <p>The Organizing Member Federation is responsible that there are enough FIG brevetted judges present with the appropriate valid category of brevet for their function. Should there not be sufficient judges as per the on-line nominative</p>

	<p>registration the Organizing Member Federation must propose to the FIG for prior approval of the FIG Technical Delegate the name of neutral additional judges to complete the panels (plus 2 reserves, 1 for MAG and 1 for WAG).. These judges, once approved, have to be invited at the cost of the Organizing Member Federation. Such invitation must be made through the respective Member Federation. Should the Organizing Member Federation fail to propose names for additional judges, the FIG Office in consultation with the FIG Technical Delegate concerned will invite these judges at the cost of the Organizing Member Federation. For additional judge's requirements see the Specific Judges' Rules.</p>																		
<p><b>SCORING AND RESULT SERVICE</b></p>	<p>GRB scoring system will be the official Scoring and Result Service System for this FIG Apparatus World Cup. This System will provide appropriate outputs, including a high-quality video control system (FIG TR).</p>																		
<p><b>VIDEO CONTROL SYSTEM</b></p>	<p>Should IRCOS not be available, the Organizing Member Federation must provide a high-quality video system (as per the Technical Regulations, Section 1, Art. 4.10.4.1) which allows the recording, storage and provision of compilation of the recorded images for the Difficulty Judges, the Supervisors and the Technical Delegate.</p> <p>During the competition, the system must be able to redisplay in real time, normal speed, slow motion or fixed image, the different sequences and the registered scores:</p> <ul style="list-style-type: none"> <li>• of one single apparatus for the Difficulty Judges' Panel of the apparatus and the Supervisor</li> <li>• of all gymnasts and all apparatus, even if they already performed, exclusively for the Supervisors and the Technical Delegate</li> </ul>

In case a gymnast received a DNS/DNF during the Apparatus Finals, points will be awarded based on the Qualifications ranks.

If after application of the tie breaking rules outlined in the Technical Regulations, Section 2, there is still a tie, the points of the equal ranks will be added and divided by the number of ties.

**WINNER OF THE ANNUAL APPARATUS WORLD CUP SERIES**

The winner of the annual Apparatus World Cup Series is the gymnast with the highest number of Apparatus World Cup points on the respective apparatus after the last event of the year, taking into consideration the best results (maximum 4), regardless of the number of competitions the athletes participated in.

In case of a tie in ranks in the Apparatus World Cup Ranking List concerned, the tie will be broken by respecting the following criteria:

- a. The ranks of the max. four (4) counting exercises will be added and the gymnast with the lowest total prevails.

Note: in case of a tie in the ranks to determine the four counting exercises, the exercises with the highest final scores will prevail.

	<p>b. If the tie remains, the final scores of the max. four (4) counting exercises will be averaged and the gymnast with the highest average prevails.</p> <p>c. If the tie remains, the total E-scores of the max. four (4) counting exercises (max. eight (8) scores for Vault) will be averaged and the gymnast with the highest average prevails.</p> <p>d.
