

JUDGES AND JURIES	<p>Each Federation must register two judges for the Individual competition and two judges for groups competition. The fine for not registering the required number of judges for the competitions in which the Federation participates will be USD \$1,200 for each missing judge (Individual and group competitions). This fine must be paid to CONSUGI in cash during the accreditation process (this does not apply to Federations that do not have FIG brevet judges in the respective competition).</p>																																					

	<p>The National Federation must inform CONSUGI in advance (at the time of final registration) to allow for the assignment of a neutral guest judge. All judges must have a current valid FIG brevet at the time of the event, for the respective discipline.</p>

Each country must submit 12 exercises to compete in the team competition.

The 10 best scores will be considered for INDIVIDUAL TEAM classification*. For the classification of the TEAM COMPETITION (RGI+RGG), the two best scores for each apparatus will be taken, for a maximum of two scores per apparatus.

B. INDIVIDUAL ALL-AROUND COMPETITION

The program consists of four SENIOR exercises, using the assigned apparatuses. The gymnast with the highest score for the sum of the four exercises will be declared the champion.



C. INDIVIDUAL APPARATUS FINALS.

The top 8 gymnasts (maximum 2 per country) from the qualifications on each apparatus in the program are designated to participate in the individual apparatus finals. The gymnast with the highest score on each apparatus will be declared the champion.

A. QUALIFICATIONS AND ALL-AROUND COMPETITION

Countries participating in the All-Around Competition must present two different routines. They may enter a maximum of 5 or 6 gymnasts for the complete program of group exercises (2 qualifications and 2 finals). If they enter 6 gymnasts, each of the 6 must perform at least one routine. Group exercises must be performed by 5 gymnasts. If one of the gymnasts does not participate in any of the routines, the group will be disqualified.

In the case of 6 gymnasts, the composition of the two routines must be declared at the time of nominative entry. The identity of each gymnast will be verified on the competition floor. Group exercises must be performed by 5 gymnasts. A group composed of a different number of gymnasts will not be permitted. The music for the different routines may be different or identical.

The group with the highest score from the sum of the scores obtained in the two exercises will be declared the champion.

B. FINAL WITH ONE TYPE OF APPARATUS/ WITH TWO TYPES OF APPARATUS.

The top eight groups in the all-around competition for each type of apparatus advance to the final.

INTERNATIONAL TRANSPORTATION

Airport Reception: Properly identified personnel from the Local Organizing Committee (LOC) will be present at Internacional Silvio Petirosi Airport to greet all delegation members.

Punctuality in submitting the form is important to ensure proper planning for the pick-up of delegations. Any delay could affect the availability of transfer services. Therefore, it is recommended that you verify that all itinerary information (dates, times, airlines) is accurate to avoid inconveniences.

LOCAL TRANSPORTATION

Transportation to and from the airport: The LOC will provide transportation between the airport and official accommodation, both upon arrival and departure, on the official dates established by the organizers.

Transportation during the event: Regular transportation will be available from the official accommodation to the competition and training venues, and vice versa, in accordance with the official program of activities. This service will be available exclusively to members of delegations with valid registration and accreditation.

Recommendations: Delegations must ensure that all members are properly registered and accredited to access the transportation services provided by the LOC. For transportation on non-official dates, it is recommended that reservations be coordinated and confirmed well in advance.
