JUDGES AND JURIES	<p>Every participating Club or Federation with 3 or more competitors has to participate at least with 1 judge. When 10 or more competitors are registered, they have to participate with at least with 2 judges. Judges must be available on every competition days.</p> <p>If not, a penalty of € 50.- will be calculated for each competitor. The same penalty will be payable in case of withdrawal at any moment or last-minute absence of Judges.</p> <p>The non-payment of the fine will remove the participation in the event of the respective competitors.</p> <p>All the judges indicated by the respective delegations, will have to be present at the respective judges' meetings.</p> <p>Note: Transport, accommodation, and meals of the judges of each delegation are of the respective delegation responsibility.</p> <p>All judges must have a current valid FIG brevet at the time of the event, for the respective discipline.</p>
