AGE LIMITS	Seniors , as per FIG technical regulations Junior , as per FIG technical regulations All gymnasts must have a valid FIG license until the end of the event! An international event will also be held for Youths and National Development. For more information see the Additional information at the end of this Directives, as well as please contact the LOC.								
JUDGES AND JURIES	All judges must have a current valid category for the respective discipline (aerobic gymnastics). Every Nation should register at least one judge with a valid FIG Brevet for the current cycle. Failure to do so may result in a fine of 850 Euro to be paid to the Local Organizing Committee in order that the LOC invites neutral judge/s. The fine for missing a judge should be paid to the LOC no later than 16th of September 2026. The number of Judge’s panels will be decided depending on the number of participating competitors and judges. The Juries will be set by a draw from the judges present at the event. The priority will be given to the judges of the highest category.

In case that there are less than 9 participants per category in the Qualifications, no Qualification is necessary. In such cases the LOC will make a decision based on the total number of entries. <u>QUALIFICATIONS</u> The participation in Qualifications is limited to the units mentioned in the paragraph “Size of delegation” except for the Organizing Federation. There is no limitation to the number of units for the Organizing Federation.																																	

	<u>FINALS</u> The top 8 (eight) competitors from the Qualifications in Seniors and Juniors in each category (IW, IM, MP, TR, GR, AD) will take part in the Finals (maximum two per Category and Nation). In addition, if the organizing Federation has not qualified competitors in any category in Seniors and in any category in Juniors, it may nominate one participation in max.1 category in each - Senior and Junior of its choice.

INSURANCE	The Host Federation, the LOC and the FIG will not be held responsible for any liabilities in the event of accidents, illness (including COVID-19), repatriation, or similar occurrences. In accordance with the FIG Technical Regulations, all participating Federations are responsible for ensuring that all Delegation Members have valid insurance coverage for illness, accidents, and repatriation during the entire duration of their stay. It is mandatory that Delegation Members are covered by basic insurance (covering sickness, accident, and repatriation) in their country of residence, in order to benefit from coverage by the FIG IMSSA subsidiary insurance. 	The LOC will verify insurance coverage upon arrival. Each Delegation must present either a cover note or a photocopy of the valid insurance policy. The policy must be valid starting from the day of arrival and must remain valid for the entire duration of the stay. If a Federation cannot provide proof of valid insurance, the LOC will offer insurance coverage at the Federation's own expense if requested in advance. Based on the request the LOC will provide information about the cost.
SAFEGUARDING	From the official day of arrival until the official day of departure, all participants — including gymnasts, coaches, judges, and other Delegation Members — will have the possibility to contact the LOC Safeguarding Officer by phone or email in case of: • Harassment • Abuse of any kind • Any situation where they feel uncomfortable or unsafe The contact information for the LOC Safeguarding Officer will be provided to all Delegations upon arrival on site. INTERNATIONAL TRANSPORTATION	The invited participating Federations must pay for the travel costs of their delegation members. If persons from one delegation/Federation are arriving and departing with different flights, please fill in separate travel forms for each group of persons and indicate on the travel form the exact number of persons.
LOCAL TRANSPORTATION	Arrival and departure – Sofia or Plovdiv: The LOC may provide transportation to all delegation members, who have booked their accommodation through the LOC, from and to Sofia or Plovdiv airport, railway station or central bus station to the official hotel in Plovdiv and back on the official arrival (14th of October 2026) and departure days (19th of October 2026). The cost of the local transportation from Sofia airport, railway station or central bus station to Plovdiv (appr. 130 km) is 33 euro one way (66 euro both ways). This transportation should be requested with the official Travel form sent to the OC and LOC and should be paid to the LOC not later than 16th of September 2026. The transportation costs cannot be reimbursed. - **GR category** – max two of the gymnasts could be from a lower age group – In Youths 12-14 (born 2015 - 2017) and in ND 9-11 (born 2018 - 2019)
- **AD category** – max three of the gymnasts could be from a lower age group – In Youths 12-14 (born 2015 - 2017) and in ND 9-11 (born 2018 - 2019)

Conditions, number of units, deadlines and prices are the same as for the Seniors and Juniors. No FIG license is requested.

The Draw for the starting order for Qualifications and Finals will be done in advance by the Technical Committee of Aerobic Union Bulgaria based on the Definitive entries and will be distributed to all Nations before the Nominative entry deadline.

More information will be given with the Work Plan which will be distributed to all registered federations not later than 5th of October 2026.

For the second time the LOC will organize an additional competition/ranking during Plovdiv Cup - Team Challenge.

More information has already been sent to all National Federations.
