<b>RULES AND REGULATIONS</b>	<p>The competition will be organized under the following FIG rules, as valid in the year of the competition, except for any deviation mentioned in the World Challenge Cup Rules in Artistic Gymnastics :</p> <ul style="list-style-type: none"> <li>• Statutes</li> <li>• Technical Regulations</li> <li>• License Rules</li> <li>• Code of Points and relevant Newsletters</li> <li>• Rules for the FIG World Challenge Cup Series in Artistic Gymnastics</li> <li>• General Judges' Rules</li> <li>• Specific Judges' Rules for Artistic Gymnastics</li> <li>• Medical Organization of the Official FIG Competitions</li> <li>• Anti-Doping Rules</li> <li>• Media Rules</li> <li>• Apparatus Norms</li> <li>• Advertising and Publicity Rules</li> <li>• Accreditation Rules</li> <li>• Regulations for Awards Ceremonies</li> </ul> <p>and subsequent decisions of the FIG Executive Committee</p> <p>Federations which have not fulfilled their financial obligations towards the FIG (e.g. annual membership fees, unpaid invoices, etc.) will not be allowed to participate in this World Challenge Cup.</p> <p>Federations which have not fulfilled their financial obligations towards the Local Organizing Committee by the given deadline in these Directives may still have the possibility to participate, but the LOC will not guarantee the hotel booking, meals and local transportation.</p>																																
<b>FEDERATIONS INVITED</b>	<p>The Organising member federation may invite FIG member federations in good standing at their discretion, but must invite <u>at least</u> all Member Federations which had:</p> <ul style="list-style-type: none"> <li>– gymnasts ranked 1-50 in the qualification competitions per apparatus at the last World Championships for the 2018 World Challenge Series) preceding the respective World Challenge Cup Series.</li> </ul>																																
<b>PARTICIPATION AND FIG LICENSE</b>	<p>Only senior gymnasts in good standing with the correct age and holding a valid FIG License may participate. The Organizing Committee will be responsible for checking the validity of the gymnasts' licenses. No gymnasts will be accepted without a valid FIG License at the deadline of the Nominative Registration. <b>ENTRY FEES</b>	<p>The non-reimbursable cost for the Entry Fee (approved by the FIG) is of 35 EUR per gymnast. The payment of the entry fee must accompany the Definitive registration on March 30<sup>th</sup> 2019 at the very latest.</p>								
<b>ACCREDITATION</b>	<p>At the time of arrival, every delegation will be brought to the Accreditation centre in the Official hotel where they will receive a welcome package including all relevant information and the accreditations, which will allow access into the training and competition halls. The accreditation is personal and non-transferable and must be used at all times. In case of loss, the Head of Competition must be contacted immediately.</p> <p>The participants which will not book their arrangements through the OC, the price for accreditation is 100 € per person and include also local transportation and farewell dinner.</p>								
<b>COMPETITION FORMAT</b>	<p>The Individual Apparatus Competitions for World Challenge Cup competitions consist of: Qualifications and Apparatus Finals</p> <p><u>Qualifications:</u></p> <ul style="list-style-type: none"> <li>▪ Participation is limited to 2 gymnasts per NF on each apparatus.</li> <li>▪ The Organizing Member Federation is allowed to add (only for the qualifications) "hors concours" competitors. These competitors are in addition to the official competitors of the Organizing Member Federation, they must be named at the time of the closing of the nominative registration and they cannot qualify for the Finals. They are not eligible to receive World Challenge Cup points, they must not appear on the official results lists and they will have to start first at every apparatus.</li> <li>▪ The Organizing Member Federation is allowed to name a max. of "4 hors concours" competitors in Women's Artistic Gymnastics and a max. of "4 hors concours" competitors in Men's Artistic Gymnastics for a total of 8 "hors concours" gymnasts (i.e. while one "hors concours" gymnast can compete on more than one apparatus, not more than one "hors concours" gymnast can compete on an apparatus).</li> <li>▪ FIG Competition III rules will be applied for vault.</li> <li>▪ In case of a tie at any place, the tie-breaking rules as set up for the Olympic Games shall be applied (Technical Regulations, Section 2).</li> </ul> <p><u>Finals:</u></p> <ul style="list-style-type: none"> <li>▪ The best eight gymnasts per apparatus from the qualifications qualify for the Finals</li> <li>▪ Participation is limited to 2 gymnasts per NF and each apparatus.</li> <li>▪ In addition, the Organizing Member Federation has the right to a limited number of Wild Cards to guarantee the participation of the Host Country gymnasts in the Finals (maximum 1 man and 1 woman gymnast only at one apparatus each).</li> </ul>								

	<ul style="list-style-type: none"> <li>▪ These “Wild Card Gymnasts” must have participated at the respective apparatus in the qualification.</li> <li>▪ “Wild Card Gymnasts” will receive medals, prize money and World Challenge Cup points.</li> <li>▪ FIG Competition III rules will be applied for vault.</li> <li>▪ In case of a tie at any place, the tie-breaking rules as set up for the Olympic Games shall be applied.</li> </ul>																								
<b>DRAWING OF LOTS</b>	The gymnasts' drawing of lots for all World Challenge Cup events will take place at the FIG Office in Lausanne (SUI) within two weeks after the closing date of the nominative registration.

Please note that should the delegation would require the invitation letter in the material form they will have to cover the postage fee (DHL).</p> <p>The request must include the function, full name, gender, date of birth, citizenship and passport number, passport expiry date, the arrival and departure dates of the Delegation Member as well as the city the visa application support letter must be sent to.</p>
<b>INSURANCE</b>	<p>The Host Federation, the Organizing Committee and the FIG will not be held responsible for any liabilities in case of accidents, illness, repatriation and the like. The FIG Technical Regulations foresee that all participating Federations are responsible for making their own arrangements to have the necessary valid insurance coverage against illness, accidents and for repatriation for all the members of their Delegation. The LOC will verify the insurance upon arrival of the delegation members (e.g. cover note or photocopy of the valid policy). Delegation members with insufficient insurance cover must inform the LOC in advance.</p> <p>The LOC will subsequently offer insurance at the Federations own charge as follows: 25 € per person/day.</p>
<b>INTERNATIONAL TRANSPORTATION</b>	<p>The invited participating federations must pay for the travel costs of their delegation members.</p> <p>The Travel Schedule Form must be returned to the LOC by April 30<sup>th</sup> 2019.</p>

While the Accommodation Form must be returned to the OC as soon as possible but no later than by April 30<sup>th</sup> 2019, the number of certain type of hotel rooms is limited, therefore they will be allocated on a “first come, first serve” basis.</p> <p><b>The invited participating federations must pay for the accommodation expenses of their delegation members (see exception herein below).</b></p> <p>Cancelation policy:</p> <p><b>The full costs for the accommodation and meals must be paid to the OC by March 30<sup>th</sup> 2019 as follows:</b></p> <p>At the time of the Definitive entry - March 30<sup>th</sup> 2019 (2 months prior to the event) provisional reservations are to be placed with the LOC which must be accompanied by 50% payment of the accommodation and meals costs. Entries without the payment of the 50% of the accommodation and meals costs will be considered as invalid and will be refused. The remaining 50% of the Accommodation costs must be paid by April 30<sup>th</sup> 2019.</p> <p>In case of room cancellations until March 30<sup>th</sup> 2019 the OC will refund the complete amount of annulled rooms and meals. In case of room cancellations until April 30<sup>th</sup> 2019 the OC will refund 50 % of the amount of annulled rooms and meals. In case of room cancellations after April 30<sup>th</sup> 2019, no claims of refunds will be accepted.</p>
<b>MEALS</b>	<p>All the accommodation packages include breakfast.</p> <p>Other meals (lunch and dinner) will also be available at a price of 15 € per person per one dinner and 20 € for person per one lunch. Meal forms must be returned to the OC by April 30<sup>th</sup> 2019 at the very latest.</p> <p><b>The invited participating federations must pay for the meals expenses of their delegation members (see exception herein below).</b></p> <p>The Deadlines for meals reservations as well as their payment are the same as it is for the accommodation. Cancelation policy for accommodation is applicable for meals as well and is stated in the previous section above.</p>
<b>FINAL BANQUET</b>	<p>The final banquet will be free of charge for the participants booking their arrangements through the OC or pay accreditation.</p>
<b>FIG TECHNICAL DELEGATE AND EC MEMBER</b>	<p>The FIG Technical Delegates will be designated by the FIG.</p> <p>The FIG Technical Delegates will serve as Presidents of the Superior Jury.</p>
<b>JUDGES AND PANELS</b>	<p>Each Judge’s panel will be composed as follows:</p> <ul style="list-style-type: none"> <li>• 2 D judges, minimum 4 E judges, plus 1 Supervisor</li> </ul> <p>The number of judges’ panels will be decided by the organizing member federation depending on the number of participating competitors and judges. Not more than one judge per Federation per panel will be permitted (except for time and line judges).</p>

	<p>The judges' panels are set up by a draw from the judges present at the event. The draw must be directed by the MAG and WAG Technical Delegates. The participating member federations must send minimum one qualified judge for MAG if they participate with male gymnasts and one qualified WAG judge if they participate with female gymnasts.</p> <p><b>The Organizing Member Federation will apply a fine of CHF 2'000 per missing judge (to be paid to the LOC) should a federation fail to bring the required number of judges. This fine must be paid to the LOC by April 30<sup>th</sup> 2019.</b></p> <p>The Organizing Member Federation is responsible that there are enough FIG brevetted judges present with the appropriate valid category of brevet for their function. Should there not be sufficient judges as per the on-line nominative registration, the Organizing Member Federation must propose to the FIG for approval the name of neutral additional judges to complete the panels (plus 2 reserves, 1 man and 1 woman). These judges, once approved, have to be invited at the cost of the Organizing Member Federation. Such invitation must be made through the respective Member Federation. Should the Organizing Member Federation fail to propose names for additional judges, the FIG Office in consultation with the TC Presidents concerned will invite these judges at the cost (in terms of international and local travel, accommodation and meals) of the Organizing Member Federation. For additional judge's requirements see the Specific Judges' Rules.</p>																				
<p><b>VIDEO CONTROL SYSTEM</b></p>	<p>Should IRCOS not be available, the Organizing Member Federation will provide another video control system which allows to treat inquiries and records all exercises of the competition in a quality which allows to judge the exercises.</p>

**WINNER OF THE ANNUAL WORLD CHALLENGE CUP SERIES**

The winner of the annual World Challenge Cup Series is the gymnast with the highest number of points for each apparatus after the last event of the year as follows:

- If 4 World Challenge Cup Competitions take place per year, the best 3 are counted
- If 3 World Challenge Cup Competitions take place per year all points are counted

A special award ceremony must be held at the last World Challenge Cup competition of the year in which the World Challenge Cup winners shall receive a Cup.

Should there be a tie after the last competition, it will be broken as follows:

The number of ranks of the counting competitions achieved by the respective gymnast will be added and the gymnast with the lowest total will prevail.

If there is still a tie, the gymnast who has participated in the greater number of Finals of the counting competitions will prevail.

If there is still a tie the total score of the counting exercises will be added and the gymnast with the highest total will prevail.

If there is still a tie, the total execution score of the three counting exercises will be added and the gymnast with the highest total execution score will prevail.

If there is still a tie, the tie will not be broken.
