<p><b>JUDGES AND JUDGES' PANELS</b></p>	<p>Competitions will be evaluated by two Judges' Panels as follows:</p> <ul style="list-style-type: none"> <li>4 Difficulty (D) Judges (min. cat. 2)</li> <li>6 Execution (E) Judges (min. cat. 3)</li> <li>Time (T) and 2 Line (L) Judges (min. cat 4)</li> </ul> <p>Priority will be given to the highest categories.</p> <p>The Judges' Panels are set up by a draw from the judges present at the event. The draw will be directed by the RG Technical Delegate.</p> <p>The participating member federations must send minimum one qualified judge if they participate with individual gymnasts and one qualified judge if they participate with a group. Those judges can be the same or different.</p> <p>The Organizing Member Federation is responsible that there are enough FIG brevetted judges present with the appropriate valid category of brevet for their function. Should there not be sufficient judges as per the online nominative registration, or not sufficient cat. 1 and 2 judges, the Organizing Member Federation must propose to the FIG for prior approval of the Technical Delegate the name of neutral additional judges to complete the panels (plus 2 reserves). These judges, once approved, have to be invited at the cost of the Organizing Member Federation.</p>																																								

	<p>Such invitation must be made through the respective Member Federation. Should the Organizing Member Federation fail to propose names for additional judges, the FIG Office in consultation with the Technical Delegate concerned will invite these judges at the cost of the Organizing Member Federation.</p> <p>The Organizing Member Federation will apply a fine of CHF 2'000 per missing judge should a federation fail to bring the required number of judges. This fine must be paid to the LOC by 06 March 2020.</p>										
<b>FIG TECHNICAL DELEGATE</b>	The FIG Technical Delegate will be proposed by the FIG RG TC. He/she will serve as President of the Superior Jury.
