<b>PARTICIPATION</b>	<p>The World Cup Competitions consist of Qualifications and Finals in all 5 categories.</p> <p><b><u>Participation in the Qualifications:</u></b></p> <ul style="list-style-type: none"> <li>• All competitors must take part in the qualifications.</li> <li>• In case of a tie at any place, the tie-breaking rules as set up for the World Championships shall be applied. Nevertheless the gymnasts not qualified for the finals and with same final score will receive the same World Cup points.</li> </ul> <p><b><u>Participation in the Finals:</u></b>  Category A and B tournaments must offer a Final in all 5 categories.</p> <ul style="list-style-type: none"> <li>• The top eight units with no more than 2 per NF/per category from the qualifications qualify for the Finals. If there are less than 9 units, only 6 will proceed to the Final, with no more than 2 pairs or groups per NF.</li> <li>• In addition, if the Organizing Member Federation has not qualified in any category, it may nominate one participation in max. 1 category of its choice.</li> <li>• Maximum participation in the finals is therefore 8+1 participants in one category and 8 in the other four categories.</li> <li>• Such “Wild Card Participant” must have participated in the respective category in the qualification.</li> <li>• In case of a tie at any place, the tie-breaking rules as set up for the World Championships shall be applied.</li> </ul> <p><b><u>World Cup Competitions may exceptionally be combined with other Competition.</u></b></p> <p><b>Cancellation Policy</b></p> <ul style="list-style-type: none"> <li>▪ The <u>organizing member Federation (LOC)</u> may cancel the competition in the respective category if at the time of the definitive entry there are</li> </ul>

	<p>less than 4 units registered in a category. In case of such a cancellation, the LOC must reimburse, in full, the entry fee and payments made for accommodation. Should flights have to be cancelled due to the above, the risk is at the charge of the participating member Federations (NF).</p> <ul style="list-style-type: none"> <li>▪ The participating member Federations (NF) may cancel its participation in a specific category without any penalty or payment for fees, accommodation and meals already booked, in case of less than 4 participating units in that category after the definitive deadlines.</li> <li>▪ Procedure and deadlines for the cancellation of a category by the LOC or participation by the NF is as follows: <ul style="list-style-type: none"> <li>○ FIG shall inform LOC and NF about the participation, within 5 days after the Definitive registration deadline.</li> <li>○ LOC and NF have the possibility to cancel the event (in a specific category) respectively their participation within 5 days after information by the FIG. <p><b>“HORS CONCOURS” GYMNASTS</b></p>	<p>The Organizing Member Federation is allowed to add only for the qualifications “hors concours” competitors. These competitors are in addition to the official participants of the Organizing Member Federation’s competitors; they must be named before the start of the qualifications and <b>cannot qualify for the final</b>. They will have to start first.</p> <p>The Organizing Member Federation is allowed to name 1 Men’s Pair, 1 Woman’s Pair, 1 Mixed pair, 1 Women’s Group and 1 Men’s Group as “hors concours” competitors.</p>																																				
<p><b>FEDERATIONS INVITED</b></p>	<p>The Organising Member Federation must invite all FIG Member Federations who have paid their annual membership fee for Acrobatic Gymnastics.</p>																																				
<p><b>SIZE OF DELEGATION AND FIG LICENCE</b></p>	<p>Participation is limited to 3 “units” per NF in each category.</p> <p>Only senior gymnasts in good standing with the correct age and holding a valid FIG License may participate. The Organizing Committee will be responsible for checking the validity of the gymnast’ Licenses. No gymnasts will be accepted without a valid FIG License at the deadline of the Nominative Registration.</p> <p>The Organising Member Federation (OMF) may limit the participation with criteria to be defined by the OMF. <p><b>AGE LIMITS</b></p>	<p>Age limit: minimum 15 years (born in 2005 or before)</p>																																				
<p><b>JUDGES AND JURIES</b></p>	<p>The number of Juries (judges’ panels) may be decided by the organizing member federation depending on the number of participating competitors and judges.</p> <p>The Juries are set up by a draw - directed by the FIG Technical Representative -</p>																																				

	<p>from the judges present at the event. Priority will be given to the judges of the highest category.</p> <p>A jury must consist of one Chair of Judges' Panel, 4 Artistic, 4 Execution and 2 Difficulty judges. No panel may include more than one member from a single federation (excluding the CJP and D judges) Please see also "General and ACRO Specific Judges' Rules".</p> <p>The FIG Technical Representative will serve as President of the Superior Jury.</p> <p>Each participating federation must provide minimum one judge. Failure to do so will result in a fine of Swiss Francs 2'000.- to be paid to the Organizing Member Federation.</p> <p>The Organizing Member Federation is responsible that there are enough FIG brevetted judges present with the appropriate category of brevet for their function. Should there not be sufficient judges, the Organizing Member Federation may propose to the FIG for approval the name of neutral additional judges to complete the panels (plus 1 reserve). These judges, once approved, have to be invited at the cost of the Organizing Member Federation. Should the Organizing Member Federation fail to propose names for additional judges, the FIG will invite such judges at the cost of the Organizing Member Federation.</p>															
<b>FIG TECHNICAL DELEGATE AND EC MEMBER</b>	<p>The FIG Technical Delegate and EC member (if applicable) will be designated by the FIG.</p> <p>The FIG Technical Delegate will serve as President of the Superior Jury.</p>

<b>FINAL BANQUET</b>	<p>The accommodations package, booked through the OC, includes the closing party ticket for official delegation members (Head of Delegation, judges, coaches, athletes, managers, and doctors).</p> <p>Delegations not booking their accommodations through the Organizing Committee and additional visitors travelling with a delegation may purchase tickets to the Final Banquet for 45 Euro per person. Ticket for the Final Banquet must be purchased in advance (until 5<sup>th</sup> March in the OC Office).</p> <p>Please include orders for Closing Party tickets with the Definitive / Nominative Entry.</p>
<b>INTERNATIONAL TRANSPORTATION</b>	<p>The invited participating federations must pay for the travel costs of their delegation members.</p> <p>The Travel Schedule Form must be returned to the LOC by January 4<sup>th</sup>.</p>

<b>VISA</b>	Please verify immediately with your travel agent or the Portuguese Embassy or Consulate in your country if a visa is required for your travel to Portugal. The Organizing Committee will be happy to assist each Delegation member with an official invitation letter, provided that the request is made before <u>4<sup>th</sup> January</u> to the LOC. The request must include the function, full name, gender, date of birth, citizenship and passport number, passport expiry date, the arrival and departure dates of the Delegation Member as well as the city the visa application support letter must be sent to.
<b>INSURANCE</b>	<p>The Host Federation, the Organizing Committee and the FIG will not be held responsible for any liabilities in case of accidents, illness, repatriation and the like. The FIG Technical Regulations foresee that all participating Federations are responsible for making their own arrangements to have the necessary valid insurance coverage against illness, accidents and for repatriation for all the members of their Delegation (except for gymnasts and judges).</p> <p>The LOC will verify the insurance upon arrival of the delegation members (e.g. cover note or photocopy of the valid policy). Delegation members with insufficient insurance cover must inform the LOC in advance. The LOC will subsequently offer insurance at the Federations own charge as follows: 40 EURO per person/day.</p>
<b>ACCREDITATION</b>	<p>Accreditations will be given at the "<u>Maia Gymnastics Complex</u>" at the arrival of the Delegations.</p> <p>The FIG Gymnast License must be presented and checked upon accreditation.</p> <p>Gymnasts who do not present a valid FIG License are not allowed to compete.</p> <p>If the gymnast is not able to show her License at accreditation, the Organizing Committee may check on the official FIG Website if the gymnast has a valid License. If this can be verified in due time by the Organizing Committee, the gymnast may participate in the competition by paying a fee of <b>20 Euro</b> to the Organizing Committee. If the gymnast has not a valid license she cannot participate in the competition.</p> <p>A photo of each member of the delegation (in electronic format .jpg must be sent together with the nominative registration – <u>no later than 4<sup>th</sup> February</u>).</p> <p>Please note: Photos not emailed and taken upon arrival will be charged to the National Federations at a cost of <b>10 Euro / each</b>.</p> <p>In addition, the LOC will distribute information regarding the gymnasts' safeguarding plan.</p>
<b>FINANCIAL OBLIGATIONS</b>	<p>Federations which have not fulfilled their financial obligations towards the FIG (e.g. annual membership fees, unpaid invoices, etc.) will not be allowed to participate in these World Cups.</p> <p>Federations which have not fulfilled their financial obligations towards the LOC by the given deadline in the Invitation/Directives, may still have the possibility to participate, but the LOC will not guarantee the hotel booking, meals and local transportation.</p>

<b>CANCELLATION POLICY</b>	<p>The Organizing Committee may fix the deadline for non-reimbursement payments. In this case the deadline for non-reimbursement accommodation, meals and banquet, must be 3 (three) days after the deadline for Definitive Registrations, at the very earliest.</p> <p>Accommodation fees are non-refundable after 4<sup>th</sup> February.</p>

<b>ASSIGNMENT OF WORLD CUP POINT FOR THE RANKING LIST</b>	<p>In principle, the results and the updated FIG World Cup Ranking List will be published on the FIG web site within 24 hours after the end of the competitions provided that all procedures before and after the competitions are duly respected by the Organizing Member Federation.</p> <p>Separate World Cup Series Ranking Lists are established for every category beginning with the first World Cup event of the year and ending with the last World Cup event of the year as follows:</p> <ul style="list-style-type: none"> <li>• Men's Pairs</li> <li>• Women's Pairs</li> <li>• Mixed Pairs</li> <li>• Women's Groups</li> <li>• Men's Groups</li> </ul> <p>Pairs are listed <b>by name</b>, but considered <b>as an entity</b>.  In case of change of partner, the Mixed Pair is considered as a new Pair.</p> <p>Groups are listed <b>by name</b>, but considered <b>as an entity</b>.  One change of name in a Trio is allowed, but in case of a second change of name, the Trio is considered as a new Trio.</p> <p>The World Cup Points are assigned to the competitors as follows:</p> <p><b>Finals:</b> ranking from 1st to 8th place (or 1<sup>st</sup> to 6<sup>th</sup> place)</p>



**Qualifications:** ranking from 9th to 16th place (or 6<sup>st</sup> to 9<sup>th</sup> place)

In the case that there are less than four (4) federations participating per apparatus or per category, no World Cup Points will be given.

“Wild Card Participants” will not receive any World Cup Points.

“Hors concours competitors” will not receive World Cup Points.

**WINNER OF THE ANNUAL WORLD CUP**
