The Technical Delegate, accompanied by the Technician of the Apparatus Manufacturer will proceed to the apparatus control in the competition hall, warm-up hall and training hall(s) prior to training and competition.

The Apparatus control includes the check of the dimensions of the RG competition floors which must respect the valid FIG Apparatus Norms. All floors must be set up correctly and the RG competition floors in the different halls must be identical.

JUDGES AND JUDGES' PANELS

Competitions will be evaluated as follows:

Individual competitions – single event part of the qualifying Series for the Olympic Games Tokyo 2020

Two Panels of Judges, per panel:

- 6 Supervisors (SJ) – cat. 1 or 2, nominated by FIG
- 4 Difficulty (D) Judges - min. cat. 2
- 2 Reference Judges (ETR) - min. cat. 2, nominated by FIG
- 6 Execution (E) Judges - **min. cat. 2**
- 2 Line (L) and 1 Time (T) Judges - **min. cat. 3**

Group competitions – non qualifying event for the Olympic Games Tokyo 2020 (no changes from previous years):

One Panel of Judges, per panel

- 4 Difficulty (D) Judges - min. cat. 2
- 6 Execution (E) Judges - min. cat. 3
- 2 Line (L) and 1 Time (T) Judges - min. cat. 4

The Judges' Panels will be set up by a draw directed by the RG Technical Delegate from the judges present at the event. Priority will be given to the highest categories.

The participating member federations must send minimum one qualified judge if they participate with individual gymnasts and one qualified judge if they participate with a group.

The Organizing Member Federation is responsible that there are enough FIG brevetted judges present with the appropriate valid category of brevet for their function. Should there not be sufficient judges as per the online nominative registration, or not sufficient cat. 1 and 2 judges, the Organizing Member Federation must propose to the FIG for prior approval of the Technical Delegate the name of neutral additional judges to complete the panels (plus 2 reserves). These judges, once approved, have to be invited at the cost of the Organizing Member Federation.

Such invitation must be made through the respective Member Federation. Should the Organizing Member Federation fail to propose names for additional judges, the FIG Office in consultation with the Technical Delegate concerned will invite these judges at the cost of the Organizing Member Federation.

50 % of the costs for accommodations must be paid to the LOC by **12 February 2021** at the time of the Definitive registration.

The remaining costs for the accommodations must be paid to the LOC by **12 March 2021** as follows: 50% by the deadline for the Nominative registration.

The non-reimbursable Administrative fee is as follows:

Please note that this fee should be transferred along with the 50 % accommodation costs.

TIE BREAKING RULES

In case of a tie at any place, the tie breaking rules as outlined in the current FIG Technical Regulation Section 3 for the RG World Championships shall be applied.

After application of the tie breaking rules outlined in the current FIG Technical Regulation Section 3, if there is still a tie:

For participation to the Apparatus Final (Individual) and Final Routine (Group):

- If there is still a tie, the tied gymnasts / groups will proceed to the final

For Prize money:

- The prize money of the tied ranks will be added and divided by the number of ties.

For World Cup Points:

- The World Cup points of the tied ranks will be added and divided by the number of ties.

For Yearly winner ([Rules for the FIG RG World Cup Series 2017-2020/2021](#)):

- The number of ranks of the three counting competitions achieved by the respective gymnast/group will be added and the gymnast/group with the lowest total will prevail.
- If there is still a tie, the total score of the three counting exercises will be added and the gymnast/group with the highest total will prevail.
- If there is still a tie, the total execution score of the three counting exercises will be added and the gymnast/group with the highest total execution score will prevail

The results and the updated FIG World Cup Ranking List will be published on the FIG website within 24 hours after the end of the respective competitions provided that all procedures before and after the competitions are duly respected by the Organizing Member Federation.

Separate World Cup Ranking Lists for:

- Individual All-Around
- Individual per apparatus
- Group All-Around
- Group Routine

are established for the four World Cup Series, beginning with the first World Cup competition of the series and ending with the last World Cup event of the series (4 competitions).

For the Individual All-Around and Apparatus Ranking Lists, World Cup Points are assigned to the competitors **by name**.

For the Groups All-Around and Routine Ranking Lists, World Cup Points are assigned to the **Federation**. The Groups are listed **by Federation** only.

OLYMPIC QUALIFICATION RANKING LIST

The 2021 RG World Cup Series Ranking List for **Individual All-Around** will be qualifying for the Olympic Games Tokyo 2020.
The Olympic Qualification Ranking list will be established after the last competition of the 2021 World Cup Series. The assignment of World Cup points for each competition will be the base to establish the Olympic Qualification Ranking list. However, gymnasts who obtained a quota place for their NOC (1 or 2) at the 2019 Baku World Championships, will be deleted from the list of each competition and the number of points earned will be assigned to the next eligible gymnast.

YEARLY WINNER OF THE WORLD CUP SERIES

The yearly winner of the World Cup Series is the gymnast / group with the highest number of points of each of the World Cup Series Ranking List after the last event of the series, counting the best results (maximum 3, **regardless of the number of competitions the gymnast participated in**).

A special award ceremony will be held at the last World Cup Competition of the year in which the winning gymnasts/groups shall receive a Cup.
