Group competitions – non qualifying event for the Olympic Games Tokyo 2020 (no changes from previous years):

The Judges' Panels will be set up by a draw directed by the RG Technical Delegate from the judges present at the event. Priority will be given to the highest categories.

The participating member federations must send minimum one qualified judge if they participate with individual gymnasts and one qualified judge if they participate with a group.

The Organizing Member Federation is responsible that there are enough FIG brevetted judges present with the appropriate valid category of brevet for their function. Should there not be sufficient judges as per the online nominative registration, or not sufficient cat. 1 and 2 judges, the Organizing Member Federation must propose to the FIG for prior approval of the Technical Delegate the name of neutral additional judges to complete the panels (plus 2 reserves). These judges, once approved, have to be invited at the cost of the Organizing Member Federation.

Such invitation must be made through the respective Member Federation. Should the Organizing Member Federation fail to propose names for additional judges, the FIG Office in consultation with the Technical Delegate concerned will invite these judges at the cost of the Organizing Member Federation.

50 % of the costs for accommodations must be paid to the LOC by **12 February 2021** at the time of the Definitive registration.

The remaining costs for the accommodations must be paid to the LOC by **12 March 2021** as follows: 50% by the deadline for the Nominative registration.

The non-reimbursable Administrative fee is as follows:

EUR 5 per delegation member

Please note that this fee should be transferred along with the 50 % accommodation costs.

In case the event is cancelled due to force-major circumstances or in case your team cannot come, all costs will be reimbursed with the exception of these 5 EUR per person – they would serve to cover costs for the LOC, arising from the reimbursement of the money.

In case the event goes as planned and your delegation participates, these 5 EUR will be taken out of the accommodation costs, i. e. no administrative fee will be taken from the delegation.

While the Accommodation Form must be returned to the LOC by **08 January 2021** at the very latest, the Hotel rooms will be allocated on a "first come, first serve" basis. CANCELLATION POLICY

Accommodation:

50% of Accommodation cost shall be reimbursed if the cancellation occurs up to 1 month prior to the event (**09 March 2021**). After, no reimbursement will be made.

LOCAL TRANSPORTATION

The LOC will provide local transportation (i.e. from/to the airport, railway station and/or bus station as well as from/to the hotel and the Competition, Training, and Warm-up Halls and from/to any other official activity) for the period from 24 March (arrival day) to 29 March 2021 (departure day) inclusive for the delegation members who book their accommodation through LOC.

VISA

The LOC will be happy to assist each Delegation member with an official invitation letter, provided that the request is made before **12 February 2021** to the LOC. The request must include the function, full name, gender, date of birth, citizenship and passport number, passport expiry date, the arrival and departure dates of the Delegation Member as well as the city the visa application support letter must be sent to.

In order to avoid the risk of no visa issuing because of late requests the LOC recommends to the participating federations to send extended lists of participants by the above-mentioned deadline.

Bulgaria applies a visa-free system for holders of valid Schengen visas.

INSURANCE

The Host Federation, the LOC and the FIG will not be held responsible for any liabilities in case of accidents, illness, repatriation and the like. The FIG Technical Regulations foresee that all participating Federations are responsible for making their own arrangements to have the necessary valid insurance coverage against illness, accidents and for repatriation for all the members of their Delegation. The LOC will verify the insurance upon arrival of the delegation members (e.g. cover note or photocopy of the valid policy).

ACCREDITATION

Accreditation of all delegations will take place at the venue of the event upon their arrival.

For Yearly winner (Rules for the FIG RG World Cup Series 2017-2020/2021):

- The number of ranks of the three counting competitions achieved by the respective gymnast/group will be added and the gymnast/group with the lowest total will prevail.
- If there is still a tie, the total score of the three counting exercises will be added and the gymnast/group with the highest total will prevail.
- If there is still a tie, the total execution score of the three counting exercises will be added and the gymnast/group with the highest total execution score will prevail
