ART. 1 GENERAL PRINCIPLES

The World Cups consists of a minimum of 3 events and a total of maximum 8 events and shall take place as follows:

Only one World Cup may be assigned per member federation. Should there be less than 8 events per year, the Executive Committee (EC) may assign a World Cup to the same Member Federation.

ART. 2 RIGHTS AND ADVANTAGES OF FIG WORLD CUP COMPETITIONS

- Each event may use the official title of "FIG World Cup Competition XXX".
- Each event will contribute Points to the respective World Cup Ranking Lists.
- Each event will be considered as an official FIG event.
- Each event will be listed in the official FIG calendar of events.
- The events dates will be protected by FIG.
- Each event will be announced in the FIG *World of Gymnastics* magazine.
- Each event will be published on the FIG Official website (www.gymnastics.sport)
- Each event (calendar) will be published and updated regularly on all FIG Communication platforms
- The Organizing Committee (LOC) of each event will be entitled to use the services of the FIG Office to send information to all FIG Member Federations by e-mail and/or through the official FIG Website
- The LOC of each event will be entitled to use the FIG Logo on official communications, posters, and programme. This does not apply for any selling item (i.e. T-Shirts, souvenirs, etc.)
- The LOC of each event will be entitled to require assistance from the official AER Technical Delegate (TD) and the FIG EC Member (if appointed).
- Each event will be included in the official FIG result service system (publication of the results on the FIG website).

ART. 3 CANDIDATURES, APPLICATIONS AND ASSIGNMENT

Art. 3.1 Bids and Criteria for Approval

Bids for the World Cup Competitions must be received at the FIG Office by 30th June (23:59 hours, CET) of the previous year for the following year. The World Cup Competitions for the next season will be assigned by the FIG EC in August of the previous year.

Should the EC not be in a position to approve at least three bids, the FIG Aerobic Gymnastics World Cup Series will not take place.

Candidatures can only be submitted by FIG Member Federations. To be approved, the following minimum requirements must be met:

- All World Cup Competitions must offer competitions in the following 5 categories: Individual men, individual women, mixed pairs, trios, groups categories.
- Organising Member federations may also offer competitions in Aerobic Step (AS) and Aerobic Dance (AD) which can be held at the same time and within the competition schedule

of the World Cup. AS and AD competitions will not generate any World Cup points and prize money for these two categories is not compulsory. Provided that there is a participation of at least 4 units, medal award ceremonies will be held, and medals must be awarded.

- Although the World Cup competitions are distinct competitions, the organizer may hold other competitions at the same site and date, if these competitions do not interfere with the training and competition schedule of the World Cup competition. The directives for these competitions must be sent to the FIG together with the application for the World Cup competition.
- In addition, a detailed list of equipment (as well as the name of the products with reference number or article number, as defined on the FIG website) to be used must be completed and submitted to the FIG Office no later than 6 months before the competition.
- Minimum 2 certified competition floors of the same manufacturer and product must be available.
- The Organizing Member Federation must offer minimum two different hotel categories, including the Official Hotel and one being a “low-cost hotel”. The prices charged for the hotel rooms cannot exceed the usual hotel rates.
- The Organizing Member Federation must pay a non-refundable application fee to the FIG of CHF 1'000. This fee must accompany the directives and forms. The application fee will only be returned in full, should the application not be considered by the FIG EC.
- The Organizing Member Federation applying for a World Cup must pay a deposit of CHF 2'000.- to the FIG. This deposit must accompany the directives and forms. The deposit will be returned in full, should the FIG decide not to assign the World Cup to the Organizing Member Federation. The deposit will also be returned in full after the event, provided all conditions of these Rules are fulfilled. Infractions and/or non-fulfilment of conditions set out in these Rules will result in the FIG not returning the deposit in full. The deposit will be lost in full (i.e. stay with FIG) if the dates, the city, or the venue of World Cup are changed by the Organizing Member Federation or if the World Cup cannot be organised by the Organizing Member Federation.
- Late applications, applications which are not complete, or are not accompanied by the application fee and the deposit are refused.

Art. 3.2 Assignment of World Cup Competitions by the FIG EC

Preference is given to organisers offering the World Cup Competition each year of the series, at the same place and the same period of the year.

World Cups must offer a Final in all 5 categories.

Upon confirmation of the directives and forms from the FIG Office, the organizers must invite the eligible Member Federations at least four months prior to the date of the event.

ART. 4 RULES AND REGULATIONS

The competition must be organized under the following FIG rules, as valid in the year of the competition, except for any deviation mentioned in these World Cup Competition Rules for Aerobic Gymnastics:

- Statutes
- Code of Ethics
- Code of Conduct
- Technical Regulations
- Code of Points and relevant Newsletters
- General Judges' Rules
- Specific Judges' Rules for Aerobic Gymnastics
- Anti-Doping Rules

- Licence Rules
- FIG Framework for Safeguarding Athletes and other Participants from Harassment and abuse in Sport during Events
- Medical Organization of the FIG Competitions and Events
- Media Rules
- Apparatus Norms
- Rules for Advertising and Publicity
- Rules for Awards Ceremonies
- Accreditation Rules

and subsequent decisions of the FIG EC

ART. 5 COMPETITION FORMAT AND PARTICIPATION

Qualifications and Finals in all 5 categories:

Art. 5.1 Qualifications

Participation is limited to 2 units per NF in each category.

The Organizing Member federation is allowed to add only for the qualifications “hors concours” competitors. These competitors are in addition to the official participants of the Organizing Member Federation’s competitors, they must be named at the time of the closing of the nominative registration and cannot qualify for the final.

The Organizing Member Federation is allowed to name 1 Individual Men, 1 Individual Woman, 1 Mixed pair, 1 Trio and 1 Group as “hors concours” competitors.

They will have to start first; they are not eligible to receive World Cup Points and prize money and they must not appear on the official results lists.

In case of a tie at any place, the tie-breaking rules as set up for the World Championships shall be applied. If there is still a tie, the tie shall not be broken. World Cup points will be assigned as foreseen in art. 15. If a tie remains at a rank qualifying for the finals, all tied units will proceed to the final.

Art. 5.2 Finals

- The top eight units per category from the qualifications qualify for the Finals.
- In addition, if the Organizing Member Federation has not qualified in any category, it may nominate one participation in max. 1 category of its choice (indicated as “Wild Card Participant”).
- Maximum participation in the finals is therefore 8+1 participants in one category and 8 in the other four categories.
- Such “Wild Card Participant” must have participated in the respective category in the qualification.
- “Wild Card Participants” will receive medals and prize money, but they will not receive any World Cup Points.
- If there are less than 4 units participating in a category, no medals, prize money and World Cup Points will be awarded.

In case of a tie at any place, the tie-breaking rules as set up for the World Championships shall be applied.

Art. 5.3 Cancellation Policy

- The **organizing member Federation (LOC)** may cancel the competition in the respective category if at the time of the definitive entry there are less than 4 units registered in a category. In case of such a cancellation, the LOC must reimburse, in full, the entry fee and

payments made for accommodation. Should flights have to be cancelled due to the above, the risk is at the charge of the participating member Federations (NF).

- The **participating member Federations (NF)** may cancel its participation in a specific category without any penalty or payment for fees, accommodation and meals already booked, in case of less than 4 participating units in that category after the definitive deadlines.
- Procedure and deadlines for the cancellation of a category by the LOC or participation by the NF is as follows:
 - FIG shall inform LOC and NF about the participation, within 5 days after the Definitive registration deadline.
 - LOC and NF have the possibility to cancel the event (in a specific category) respectively their participation within 5 days after information by the FIG. Such notification must be sent by e-mail or fax to the FIG. Cancellations after this deadline will not be accepted.

ART. 6 INVITATION

The Organising Member Federation must invite all FIG Member Federations who have paid their annual membership fee for Aerobic Gymnastics.

The Directives and forms must be approved by the FIG and published at last 5 months prior to the event. They must be submitted to the FIG as soon as possible but no later than 6 months prior to the event.

ART. 7 REGISTRATIONS AND DELEGATIONS SIZE

On-line registrations will only be accepted from FIG Gymnastics Member Federations. For delegation size please refer to FIG Accreditation Rules.

ART. 8 REGISTRATION DEADLINES

Provisional registration*	4 months prior to the competition
Definitive registration	2 months prior to the competition
Nominative registration	4 weeks prior to the competition

**Note: it is not compulsory for the Organising Member Federation to request a Provisional Registration.*

Registrations must be made exclusively on-line via the FIG online registration platform. Late registrations are subject to fines **as follows**:

Fine for missing or late Provisional registration (if any)	CHF 500.-
Fine for missing or late Definitive registration	CHF 750.-
Fine for missing or late Nominative registration	CHF 500.-

Registrations and payments made after the gymnasts' drawing of lots will not be accepted and the Delegation members concerned will not be authorized to participate.

ART. 9 FINANCIAL OBLIGATIONS FOR THE PARTICIPATING FEDERATIONS, THE ORGANIZING MEMBER FEDERATION AND FIG

Art 9.1 Financial Obligations for the participating Federations

Unless stated differently in the invitation, the invited participating federations pay for their travel, accommodation, meals and entry fees if requested by the LOC and approved by the FIG.

Federations which have not fulfilled their financial obligations towards the FIG (e.g. annual membership fees, unpaid invoices, etc.) will not be allowed to participate in these World Cups.

Federations which have not fulfilled their financial obligations towards the LOC by the given deadline in the Invitation/Directives, may still have the possibility to participate, but the LOC will not guarantee

the hotel booking, meals and local transportation. Federations which have not fulfilled their financial obligations towards the Organizing Member federations upon arrival will not be accredited.

Art 9.2 Financial Obligations for the organising member Federations and the FIG

The Organising Member Federation is responsible for:

- All costs for the preparation and the running of the event
- TV production costs (not compulsory)
- Scoring and result service as per FIG requirements
- Application fee and deposit to the FIG
- Local travel expenses as well as the accommodation costs (single room incl. breakfast) for the AER TD
- International and local travel, accommodation (single room incl. breakfast) , and meals costs for any invited neutral judges approved by FIG
- Local transportation and hotel accommodation (single room incl. breakfast) for one FIG EC member if appointed by the FIG President
- Local transportation and hotel accommodation (single room incl. breakfast) for one FIG staff member if appointed by the FIG
- FIG regular competition fee as decided by the Council (fees for senior events CHF 200, plus 5% of the prize money).

Prize Money. The FIG shall pay for:

- International travel expenses and the Per Diem, including the Travel Days for the AER Technical Delegate
- International travel expenses and the Per Diem costs (including the travel days) for one FIG EC member if appointed by the FIG President
- International travel expenses and the Per Diem costs (including the travel days) for one FIG staff member if appointed by the FIG.

ART. 10 PRIZE MONEY

The organising member federation must pay a minimum prize money per medallist as follows:

The prize money and its distribution per rank must be mentioned in the directives.

In case of a tie, the prize money will be added and divided by the number of units:

1, 1, 3 (prize money for rank 1 and 2 is added and divided by 2)

1, 2, 2, (prize money for rank 2 and 3 is added and divided by 2)

No prize money, medals and World Ranking Lists points will be given, if there are less than 4 participating units per category. This must be mentioned in the invitations.

The LOC will not be responsible for any local taxes payable in the beneficiary's residence country.

ART. 11 JURIES

Technical Delegate

The respective Technical Committees will propose at least 3 months prior to the date of the event a Technical Committee member or an expert (to be approved by the FIG President) to serve as Technical Delegate. This TD must receive all information from the LOC, and he/she must be present at the event. The TD will serve as President of the Superior Jury.

Judges' Panel

The number of Judges' Panels may be decided by the organizing member federation depending on the number of participating competitors and judges.

The Judges' Panels are set up by a draw - directed by the FIG TD from the judges present at the event. Priority will be given to the judges of the highest category.

A jury must consist of one Chair of Judges' Panel, 4 Artistry, 4 Execution and 2 Difficulty judges.

A federation may not have a judge on both the execution and Artistry panels. The Chair of Judges' Panel and the difficulty judges should also be from different federations. Only in exceptional situations can the TD make the decision to deviate from this.

The CJP must be of cat. 1.

The Difficulty Judges must be cat. 1 or 2.

The Execution and Artistry judges must be cat. 1, 2 or 3.

Each participating federation must provide minimum one judge, cat 1, 2 or 3*. Failure to do so, or if a participating Federation sends a judge with a cat. 4 (instead of Cat. 1, 2 or 3) will result in a fine of CHF 2'000.- to be paid to the Organizing Member Federation. This provision must be mentioned in the directives.

*Member Federations who have only cat. 4 judges are allowed to send a Cat. 4 judge who may be used as Time and Line judge only.

The Organizing Member Federation is responsible that there are enough FIG brevetted judges present with the appropriate category of brevet for their function.

Should there not be sufficient judges, the Organizing Member Federation must propose at the time of the nominative entry to the FIG for approval the name of neutral additional judges to complete the panels (plus 1 reserve). These judges, once approved, have to be invited at the time of the nominative entry at the cost of the Organizing Member Federation. Such invitation must be made through the respective Member Federation.

Should the Organizing Member Federation fail to propose names for additional judges, the FIG will invite such judges at the cost of the Organizing Member Federation.

Video control system

Should IRCOS not be available, the Organizing Member Federation must provide another video control system which allows to treat inquiries and records all exercises of the competition in a quality which allows to judge the exercises. This video control system must be approved by the TD before the start of the competition.

The videos or DVDs must be sent to the FIG office within one week after the competition.

ART. 12 APPARATUS AND APPARATUS CONTROL

All apparatus must have a valid FIG certificate no later than six months prior to the event and until the end of the event. The Organising member Federation must inform FIG at least six months prior to the event about the name of the Apparatus Manufacturer and in addition must provide a detailed list of certified equipment (as well as the name of the products as defined on the certificate and published on the FIG website).

The Organising member Federation must enter into a service agreement with the official apparatus manufacturer which guarantees the presence of at least one technician for the installation of the competition floors in the competition hall (and the warm-up hall, and the training hall(s) if available), as well as throughout the duration of training, podium training, warm-up, and competition. A copy of the service agreement must be sent to the FIG at least six months prior to the event.

The control of the competition floors in the competition hall (and in the warm-up hall and training hall(s) if available) prior to training is the responsibility of the FIG TD. The TD will be accompanied by a technician of the Apparatus Manufacturer and the local Competition Director.

The apparatus control includes the check of the dimensions which must respect the valid FIG Apparatus Norms. It must be verified that the duly certified apparatus are set up correctly and that the apparatus in the different halls are identical.

A written report (see Control Form in the Apparatus Norms) about all the problems faced must be established. Adjustments must be made by the apparatus manufacturer concerned in cooperation with the LOC. The TD will approve the use of the apparatus by the gymnasts, after verifying that the adjustments have been made.

During the competitions, the TD is responsible for the apparatus control.

ART. 13 MEDIA REQUIREMENTS

Art. 13.1 Media Rights across all means and Marketing Rights

Media Rights across all means and reproduction rights together with publicity and marketing rights concerning the World Cup events are the property of the FIG.

Art. 13.2 Media Rights across all means – Definition

The right during the Term to Exploit Footage of the Event throughout the Territory in any format and by all means, media and technologies (whether now known or invented) via any service and in any form for any purpose that FIG shall determine (including, without limitation, free and pay services, in the form of or via services which include any enhanced or interactive functionality and whether linear or on-demand and in whole and in part (including without limitation in the form of clips and highlights).

Art. 13.3 Media production

Minimum production for Webcasting is compulsory for World Cups events.

The Organizing Member Federation must guarantee the production of a basic feed (international signal). The International signal must be available for the FIG without any limitations and free of any access fees.

FIG releases all Media Rights across all means to the Organizing Member Federation. The Media rights are released free of charge and granted exclusively for a period of until two weeks after the competition and then on a non-exclusive basis until one year after the event. Then the rights are back with the FIG.

The release of the Rights shall only be effective under the condition that:

- Each Organizing Member Federation undertakes to provide the FIG Office with the contact details of the Media Production company at least six months prior to the event.
- Each Organizing Member Federation undertakes to provide the FIG Office with a copy of the basic feed (international signal) immediately after the end of the competition on site to the FIG representative. These footages are supplied to the FIG free of charge. Production costs and postage are at the cost of the Organizing Member Federation. FIG may use the footage at its discretion.
- Each Organizing Member Federation undertakes to provide the FIG Office with the link to the website or video platform webcasting the competition at least one month prior to the event.

Art. 13.4 International signal- Definition

The International Signal shall be produced in accordance with the following:

- the International Signal shall be an integrated, complete, uninterrupted and continuous Live feed produced to professional sports broadcasting standard, using a minimum of two cameras in 16:9 format and include coverage not only of the competition but also of any award ceremonies.
- the International Signal shall include graphics with all text in English, including but not limited to starting lists, names of competitors, results, in accordance with applicable laws and regulations, international sound with necessary related background sound effects on at least two audio tracks.
- the International Signal shall not include any domestic elements which would not be acceptable for international distribution such as commercial elements, in-vision presenters, talking heads, interviews, commercial breaks and black holes or any other elements.
- the International Signal must include full duration coverage of the Finals with award ceremonies.

Art. 13.5 Marketing Rights

For the 2025-2028 series, the FIG releases all Marketing rights (including the publicity space on the apparatus) free of charge to the Organizing Member Federation. It is understood that the FIG Advertising and Publicity Norms must be respected.

Art. 13.6 Results

The TD is responsible that the results of the competition, signed by the respective TD, are sent by e-mail to the FIG Office immediately after the end of the respective competitions.

The results and the updated World Cup Ranking List will be published on the FIG website within 24 hours after the end of the respective competitions to the conditions that the Organizing Member Federation respects the following process:

Art. 13.6.1 Before the competition (7 days)

The FIG Office will send the event's ID, the list of registered gymnasts with their respective license number and a template of the electronic results file (empty) to the federation who organizes the competition.

Art. 13.6.2 After the competition

The organizer must return to the FIG at the end of the competition:

A copy of all detailed results (qualifications & finals) in PDF format and duly signed by the TD for archival purposes only.

Up to a maximum of 24 hours after the end of the competition, the organizer must upload the competition data (results) to the Maelstrom JEP portal, using the access credentials to be given by the FIG, once the World Cup is assigned.

The only accepted format for the upload is an XML file, with the specifications detailed on the Maelstrom JEP portal.

If the above deadlines are not respected or if the FIG does not receive any electronic results file in the format specified above, the Organizing Member Federation's deposit will be lost in full.

Art. 13.7 Photographs

A selection of high-quality (min 2048 x 1536 pixel) photographs from the event taken by an experienced sports photographer. The photos should be in high-quality JPG format with captions embedded in the metadata. They should be delivered to the FIG Communications Department (mediafig@fig-gymnastics.org) as soon as possible, but no later than 24 hours, after the event using a cloud-based application such as WeTransfer or Dropbox.

The selection should include the winners on each apparatus, the medal ceremonies and any other significant happenings during the event (e.g. visits by local or national dignitaries, FIG authorities).

ART. 14 MEDICAL INJURY REPORT FORM AND DOPING CONTROLS

The organizing member federation must provide a Gymnast injury summary report and all related injury reports or a written under medical confidentiality within 3 days after the event. Failure to do so after the first reminder will result in a deposit being lost in full confirmation that no injury occurred form listing all the injuries occurred during the event. This report must be sent to the FIG office.

For World Cups, the Organizing Member Federation has to provide a minimum of 5 doping controls at its own charge.

Failure to do so will result in the deposit being lost in full.

Doping control forms must be sent to FIG office by Doping control officer within 3 days after the event. Failure to do so after the first reminder will result in a deposit being lost in full.

ART. 15 ASSIGNMENT OF WORLD CUP POINTS FOR THE WORLD CUP RANKING LIST

Separate World Cup Series Ranking Lists are established for every category beginning with the first World Cup event of the year and ending with the last World Cup event of the year as follows:

- Men Individual
- Women Individual
- Mixed Pairs
- Trio
- Groups

For Individual competitors, World Cup Points are assigned to the competitor **by name**.

Mixed Pairs are listed **by name** but considered **as an entity**. In case of change of partner, the Mixed Pair is considered as a new Pair.

Trios are listed **by name** but considered **as an entity**. One change of name in a Trio is allowed, but in case of a second change of name, the Trio is considered as a new Trio.

Groups are listed **by Federation**. The World Cup Points are assigned to the Federation. If more than one Group per Federation starts at an event, only the better result will be considered as per the example shown below.

Example of a Ranking list and the assignment of World Cup Points

The World Cup Points are assigned as follows:

Finals: ranking from 1st to 8th place

Qualifications: ranking from 9th to 16th place

The units with same final score will receive the same World Cup points.

In the case that there are less than four units participating per category, no World Cup points, no medals and no prize money will be given.

ART. 16 WINNER OF THE ANNUAL WORLD SERIES RANKING LIST

At each event, the gymnasts will have the opportunity to win World Cup Points which will count towards the respective World Cup Ranking Lists. These World Cup Ranking Lists will begin with the 1st event of the year (i.e. per discipline) and will end with the last event of the year (i.e. per discipline).

The winner of the annual World Cup per category is the individual gymnast / pair / trio / group with the highest number of points of the World Cup Ranking List after the last event of the year as follows:

- If 5 to 8 World Cup Competitions take place per year, the best 4 (max. 4, regardless of the number of competitions the gymnast participated in) are counted.
- If 3 to 4 World Cup Competitions take place per year all points are counted, regardless of the number of competitions the gymnast participated in.

A special award ceremony will be held at the last World Cup Competition of the year in which the World Cup winner will receive the World Cup.

If there is a tie at the first place, the sum of the number of ranks of the counting competitions achieved by the respective unit will be added and the unit with the lowest total will prevail.

If there is still a tie, the unit who has participated in the greater number of Finals of the counting competitions will prevail.

If there is still a tie, the unit who has the best rank at one of the counting competitions will prevail.

If there is still a tie, the tie will not be broken.

ART. 17 DRAWING OF LOTS

The gymnasts' drawing of lots for all World Cup events will take place at the FIG Office in Lausanne (SUI) within two weeks after the closing date of the nominative registration.

After publication of the draw on the FIG website, the member Federation will be given an opportunity to modify the position of their gymnasts' starting order within 3 days by using the official document to be found on FIG website (see: Appendix 1).

These Rules have been approved by the FIG EC at its meeting February 2024 in Kampala (UGA) and enter into effect on 1st January 2025.

Appendix 1: Drawing of lots procedures

Drawing of lots procedures

The draw will decide the order in which the lot for each team, or gymnast, will be drawn and determine the order in which the team or gymnast will commence to compete in the Competition, both in qualifications and finals.

For the health and safety of gymnasts, FIG has accepted that gymnasts competing in multiple finals require 10 minutes to recover before competing again.

In AER Gymnastics the draw will be adjusted according to this principle. If a gymnast or group compete 7th in one rotation and are drawn in positions 1-3 in the next rotation the new starting position will become 4th. If a gymnast or group compete last in a rotation and are drawn in positions 1-4 in the next rotation the new starting position will be 5th (see FIG Technical Regulations, Section 1, Art 4.3)

At the time of the nominative registrations, every Federation must nominate its gymnasts on the FIG online registration.

This nomination must be made in every category, the respective Federation has made at the time of the definitive registration.

Every Federation is asked to nominate its gymnasts in the respective categories (IM, IW, MXP, TRIO and GROUP).

Two weeks after the deadline of the nominative registration, the drawing of lots will be performed.

This drawing of lots will be made by Federation (when 2 units are selected, a number one and a number two will appear in this drawing of lots).

After publication of the draw on the FIG website, the member Federation will be given an opportunity to modify the position of their gymnasts' starting order within 3 days by using the official document to be found on FIG webpage of the event on the FIG Calendar.

This document will allow every Federation to change its gymnasts', pairs', trios' and groups' position (i.e from position one to position two within the Federation).

This document is to be sent back to the FIG office, attention M. Alexandre Cola (acola@fig-gymnastics.org) no later than 3 days after publication of the drawing of lots on the FIG website.

Should no answer be received at the FIG office by the given deadline, the registration made by the respective Federation at the time of the nominative registration, will be considered as approved and final.
