B.2. Maximum number of athletes per National Olympic Committee

Maximum one team of five athletes (no reserves).

Maximum of three individual athletes for NOCs with no team qualified. These individual athletes are not allowed to compete as a team.

Maximum of three individual athletes for NOCs with no team qualified. These individual athletes are not allowed to compete as a team.

B.3. Type of allocation of quota places

The team and individual athletes' quota places are either allocated to the NOC or to the athlete by name as follows:

Quota places allocated to the NOC:

- for a team quota place allocated through Criteria 1 or 2
- for an individual athlete's quota place allocated through Criteria 3

Quota places allocated to the athlete by name:

- for an individual athlete's quota place allocated through Criteria 4, 5, 6, and 7
- for the host country quota places and the universality places

C. ATHLETE ELIGIBILITY

All athletes must respect and comply with the provisions of the Olympic Charter currently in force, including but not limited to Rule 41 (Nationality of Competitors) and Rule 43 (World Anti-Doping Code and the Olympic Movement Code on the Prevention of the Manipulation of Competitions).

Only those athletes who respect and comply with the Olympic Charter, the World Anti-Doping Code and the Olympic Movement Code on the Prevention of the Manipulation of Competitions, including the conditions of participation established by the IOC, plus the rules of the FIG, may participate in the LA28 Olympic Games.

Age Requirements

C.1. All athletes participating in the LA28 Olympic Games must have been born:

- On or before 31 December 2010 for the men's competitions, as validated by the passport used for accreditation registration. A men's athlete declared as junior prior to his first competition in 2028 will not be eligible to participate at in LA28.
- On or before 31 December 2012, as validated by the passport used for accreditation registration, for the women's competitions.

Additional IF Requirements

C.2. To be eligible to participate in the LA28 Olympic Games:

- All athletes must hold a FIG licence valid until the end of the 2028 Olympic Games artistic gymnastics competitions.
- For Criteria 1 and 2, all teams must have participated in any of the qualification events outlined in sections **D. “Qualification pathway”** and **F. “Reallocation”** to be eligible to obtain a team quota place.
- For Criteria 3, all teams must have participated in any of the qualification events outlined in sections **D. “Qualification pathway”** and **F. “Reallocation”** to be eligible to obtain an individual athlete’s quota place.
- For Criteria 4, 5, 6, and 7, all individual athletes who are not part of a team, including individual athletes receiving host country places and/or universality places, must have participated in any of the qualification events outlined in sections **D. “Qualification Pathway”** and **F. “Reallocation”** to be eligible to obtain an individual athlete’s quota place.

Qualification places:

The three highest ranked eligible NOCs, based on the team qualifications results – that have not qualified through Criteria 1 or 2, will obtain one individual athlete quota place for their NOC.

If, for any reason, the dates set for the 2027 World Championships result in delaying the announcement of qualified athletes in light of the chronological order of qualification for LA28, the three highest ranked eligible NOCs based on the team qualifications results of the last World Championships edition held with a team participation – that have not qualified through Criteria 1 or 2, will obtain one individual athlete quota place for their NOC.

- Up to a maximum of 24 teams with three to five athletes and one reserve
- A maximum of 40 men's All-Around athletes and a maximum of 56 women's All-Around athletes
- A maximum of 48 men's Apparatus athletes and a maximum of 32 women's Apparatus athletes

Qualification Places:

The highest ranked eligible athlete on each Apparatus, based on the apparatus finals results (taking into account athletes ranked 1 to 3), will obtain one quota place by name. The following athletes are not eligible to receive a quota place:

- Athletes from NOCs with a team that has qualified through Criteria 1 or 2.
- Athletes already qualified through Criteria 4.

If not all quota places can be allocated, the principles outlined in Criteria 6 will be applied to allocate first the quota places referred to in Criteria 6 and then the remaining quota places for the apparatus concerned referred to in Criteria 5, based on the 2028 Apparatus World Cup Series.

At LA28, these Apparatus athletes may participate on all apparatus in the qualifications.

If, for any reason, the dates set for the 2027 World Championships result in delaying the announcement of qualified athletes in light of the chronological order of qualification for LA28, the highest ranked eligible athlete on each Apparatus, based on the apparatus finals results (taking into account athletes ranked 1 to 3) of the last World Championships edition held, will obtain one quota place by name. The following athletes are not eligible to obtain a quota place:

- Athletes from NOCs with a team that has qualified through Criteria 1 or 2.
- Athletes already qualified through Criteria 4.

If Criteria 6 had to be used to allocate the remaining quota places for the apparatus concerned, and if, for any reason, the dates set for the 2028 Apparatus World Cup Series result in delaying the announcement of qualified athletes, in light of the chronological order of qualification for LA28, the principles outlined in Criteria 6 will be applied to allocate first the quota places referred to in Criteria 6 and then the remaining quota places for the apparatus concerned referred to in Criteria 5, based on the last Apparatus World Cup Series edition held.

D.2.3. **2028 Apparatus World Cup Series - Apparatus Athletes****Criteria 6 Participation rights:**

All FIG Member Federations in good standing may participate in each competition with a maximum of two athletes per federation per apparatus.

Qualification places:

Women

8 Athletes

The two highest ranked eligible athletes per apparatus, based on the Olympic Qualification World Cup Ranking List, will obtain a quota place by name, with a maximum of one quota place per apparatus per NOC. The following athletes are not eligible to obtain a quota place:

- Athletes from NOCs with a team that has qualified through Criteria 1 or 2,
- Athletes already qualified through Criteria 4 and 5,
- Athletes from NOCs with a maximum of three individual athletes already qualified through Criteria 3, 4, and 5.

At LA28, these Apparatus athletes may participate on all apparatus in the Qualifications.

The Olympic Qualification World Cup Ranking List will be established as follows:

- World Cup Points that count towards the Olympic Qualification World Cup Ranking List will be recalculated and assigned in accordance with the rankings allocated as outlined in the [Rules for the FIG Apparatus World Cup Series 2025-2028](#).
- The maximum four best competitions out of 6 will be considered
- Only eligible athletes will be taken into account
- On each apparatus, the eligible athlete with the highest World Cup Points that count towards the Olympic Qualification World Cup Ranking List will be considered.

If, for any reasons, the dates set for the 2028 Apparatus World Cup Series result in delaying the announcement of qualified athletes in light of the chronological order of qualification for LA28, the two highest ranked eligible athletes per apparatus, based on the Olympic Qualification World Cup Ranking List of the last Apparatus World Cup Series edition held, will obtain a quota place by name, with a maximum of one quota place per apparatus per NOC. The following athletes are not eligible to obtain a quota place:

- Athletes from NOCs with a team that has qualified through Criteria 1 or 2.
- Athletes already qualified through Criteria 4 and 5
- Athletes from NOCs with a maximum of three individual athletes already qualified through Criteria 3, 4, and 5.

D.2.4. Criteria 7 **2028 Continental Championships (or the other Continental Qualifying Event approved by the FIG) - All-Around Athletes**

Participation rights:

Participation will be open to all NOCs in good standing of the respective continent and in accordance with the continent's specific participation rights.

Qualification places:

Women
5 Athletes

The highest ranked eligible athlete based either on the All-Around Qualifications results or the All-Around final results (i.e., at the discretion of the respective Continental Union and as outlined in the Directives concerned) will obtain one quota place by name. The following athletes are not eligible to obtain a quota place:

- Athletes from NOCs with a team that has qualified through Criteria 1 or 2.
- Athletes already qualified through Criteria 4, 5, and 6
- Athletes from NOCs with a maximum of three individual athletes already qualified through Criteria 3, 4, 5, and 6.

If, for any reason, the dates set for the 2028 Continental Championships (or the other Continental Qualifying Event approved by the FIG) result in delaying the announcement of qualified athletes in light of the chronological order of qualification for LA28, the highest ranked eligible athlete based on the All-Around Qualifications results of the last Continental Championships edition held in this Continent with All-Around participation, will obtain one quota place by name.

The following athletes are not eligible to receive a quota place:

- Athletes from NOCs with a team that has qualified through Criteria 1 or 2.
- Athletes already qualified through Criteria 4, 5, and 6.
- Athletes from NOCs with a maximum of three individual athletes already qualified through Criteria 3, 4, 5, and 6.

Continental Representation:

The minimum continental representation is guaranteed with qualification through the Continental Championships (or the other Continental Qualifying Event approved by the FIG).

D.3.

HOST COUNTRY PLACES

Host Country Places Guaranteed

As soon as the participation of the Host Country at LA28 is guaranteed with a minimum of one men's athlete and a minimum one women's athlete through any Criteria outlined in section D. **"Qualification Pathway"**, the quota places will immediately be allocated by name to the next highest ranked eligible men's athlete and/or the next highest ranked eligible women's athlete without a qualified team through Criteria 1 or 2 based:

- on the All-Around Qualifications results of the 2027 World Championships
- by respecting the provision of a maximum of one quota place per NOC

If, for any reason as outlined in section D. **"Qualification Pathway"**, these quota places cannot be allocated at the 2027 World Championships, they will be allocated by name to the next highest ranked eligible men's athlete and/or the next highest ranked eligible women's athlete without a qualified team through Criteria 1 or 2 based:

- on the All-Around Qualifications results of the last World Championships edition held
- by respecting the provision of a maximum of one quota place per NOC

Host Country Places Not Guaranteed

If the presence of the Host Country is not guaranteed through any Criteria outlined in section D. **"Qualification Pathway"**, the quota places will be allocated to the highest ranked eligible men's athlete and/or the highest ranked eligible women's athlete from the Host Country by name, based on the All-Around Qualifications results of the 2027 World Championships.

If, for any reason as outlined in section D. **"Qualification Pathway"**, these quota places cannot be allocated at the 2027 World Championships, they will be allocated to the highest ranked eligible men's athlete and/or the highest ranked eligible women's athlete from the Host Country by name, based on the All-Around Qualifications results of the:

- 2028 Continental Championships (or the other Continental Qualifying Event approved by the FIG) or, if this is not possible:
- the last Continental Championships edition held with All-Around participation and Host Country participation.

D.4. UNIVERSALITY PLACES

Two universality places allocated by athlete's name will be made available to one men's athlete and one women's athlete at LA28, provided that the athlete has met the eligibility criteria as outlined in section C. **"Athlete Eligibility"**.

On 1 October 2027, the International Olympic Committee (IOC) will invite all eligible NOCs to submit their requests for universality places. The deadline for NOCs to submit their requests is 15 January 2028. The Tripartite Commission will confirm, in writing, the allocation of universality places to the relevant NOCs after the end of the qualification period for the sport concerned.

Detailed information on universality places is contained in the "Los Angeles 2028 Olympic Games - Tripartite Commission Universality Places - Allocation Procedure" document.

E. CONFIRMATION PROCESS

Confirmation of Quota Places

- E.1.** After receiving confirmation of the allocated quota places from the FIG, the NOCs will then have two weeks to confirm in writing if they wish to use these quota places, as outlined in section G. **"Qualification Timeline"**.

After this deadline, unused quota places will be reallocated as per the procedure outlined in **section F. "Reallocation"**.

Confirmation of Host Country Places

- E.2.** The host country must confirm in writing to the FIG the use of its host country places two weeks after receiving confirmation from the FIG, as outlined in section G. **"Qualification Timeline"**.

F. REALLOCATION

Reallocation of unused Quota Places

- F.1.** The reallocation of unused quota places shall be considered as distinct from the Late Athlete Replacement (LAR) Policy, which applies only to quota places allocated to an NOC (and not by name to an athlete) and is applicable from the Sport Entries Deadline until 24 hours before the start of the men's Qualifications and the women's Qualifications, respectively.

The unused allocated quota places will be reallocated, as outlined in **section F. "Reallocation"**, up until the start of the LA28 Technical Meeting for Artistic Gymnastics.

The provision of a maximum of three individual athlete's quota places for NOCs (without a team qualified) must be respected when reallocating unused allocated quota places to the next highest ranked eligible NOC (Criteria 3) or to the next highest ranked eligible athlete (Criteria 4, 5, 6, and 7).

Reallocation of unused quota places in chronological order

World Championships - Team quota places of five athletes (no reserves)

Criteria 1 and 2 allocated to the NOC

The unused allocated NOC team quota place will be reallocated to the next highest ranked eligible NOC based on the team qualifications results of the 2027 World Championships.

If, for any reason as outlined in section **D. "Qualification Pathway"**, this quota place cannot be reallocated at the 2027 World Championships, it will be reallocated to the next highest ranked eligible NOC based on the team qualifications results of the last World Championships edition held with a team participation.

If individual athlete's quota places were already allocated by name to the next highest ranked eligible NOC through criteria 4, 5, 6, or 7, these individual athlete's quota places by name will have to be included among the five athletes composing the Team (no reserves). These individual athlete's quota places by name will then be reallocated in accordance with the reallocation procedure mentioned for Criteria 4, 5, 6, or 7.

An NOC (including the host country) declining a team quota place is not eligible to convert the unused team quota place for any individual athletes' quota places.

World Championships – Individual athlete's quota places from non-qualified teams

Criteria 3, allocated to the NOC

The unused allocated NOC individual athlete's quota place will be reallocated to the next highest ranked eligible NOC based on the team qualifications results of the 2027 World Championships.

If, for any reason as outlined in section **D. "Qualification Pathway"**, this quota place cannot be reallocated at the 2027 World Championships, it will be reallocated to the next highest ranked eligible NOC based on the team qualifications results of the last World Championships edition held with a team participation.

World Championships - All-Around athlete's quota places

Criteria 4, allocated to the athlete by name

The unused allocated quota place will be reallocated by name to the next highest ranked eligible athlete, by respecting the provision of a maximum of one quota place per NOC, based on the All-Around Qualifications results of the 2027 World Championships.

If, for any reason, as outlined in section **D. "Qualification Pathway"**, this quota place cannot be reallocated at the 2027 World Championships, it will be reallocated by name to the next highest ranked eligible athlete, by respecting the provision of a maximum of one quota place per NOC, based on the All-Around Qualifications results of the last World Championships edition held.

World Championships - Apparatus athlete's quota places

Criteria 5, allocated to the athlete by name

The unused allocated quota place will be reallocated by name to the next highest ranked eligible athlete on the apparatus concerned, based on the apparatus finals results (considering athletes ranked 1 to 3) of the 2027 World Championships.

If, for any reason as outlined in section **D. “Qualification Pathway”**, this quota place cannot be reallocated at the 2027 World Championships, it will be reallocated by name to the next highest ranked eligible athlete on the apparatus concerned, based on the apparatus finals results (considering athletes ranked 1 to 3) of the last World Championships edition held.

If Criteria 6 had to be used to allocate the remaining quota places for the apparatus concerned, the principles of reallocation of unused quota places outlined in Criteria 6 based on the 2028 Apparatus World Cup Series, will be applied.

If Criteria 6 had to be used to allocate the remaining quota places for the apparatus concerned, and if, for any reason as outlined in section **D. “Qualification Pathway”**, this quota place cannot be reallocated at the 2028 Apparatus World Cup series, it will be reallocated in accordance with the principles of reallocation of unused quota places outlined in Criteria 6 based on the last Apparatus World Cup Series edition held.

Apparatus World Cup Series - Apparatus athlete’s quota places
Criteria 6, allocated to the athlete by name

The unused allocated quota place will be reallocated by name to the next highest ranked eligible athlete on the apparatus concerned, by respecting the provision of a maximum of one quota place per apparatus per NOC, based on the Olympic Qualification World Cup Ranking List of the 2028 Apparatus World Cup Series.

If, for any reason as outlined in section **D. “Qualification Pathway”**, this quota place cannot be reallocated through the 2028 Apparatus World Cup Series, it will be reallocated by name to the next highest ranked eligible athlete on the apparatus concerned, by respecting the provision of a maximum of one quota place per apparatus per NOC, based on the Olympic Qualification World Cup Ranking List of the last Apparatus World Cup Series edition held.

Continental Championships (or the other Continental Qualifying Event approved by the FIG) - All-Around athlete’s quota places
Criteria 7, allocated to the athlete by name

The unused allocated quota place will be reallocated by name to the next highest ranked eligible athlete based on the All-Around Qualifications results or the All-Around Final results (i.e., at the discretion of the respective Continental Union and as outlined in the Directives concerned) of the 2028 Continental Championships (or the other Continental Qualifying Event approved by the FIG).

If, for any reason as outlined in section **D. “Qualification Pathway”**, this quota place cannot be reallocated at the 2028 Continental Championships (or the other Continental Qualifying Event approved by the FIG), it will be reallocated by name to the next highest ranked eligible athlete based on the All-Around Qualifications results of the last Continental Championships edition held in this Continent with All-Around participation.

Reallocation of unused Host Country places

F.2. Reallocation within the host country

The unused allocated quota place will be reallocated by name to the next highest ranked eligible athlete from the host country based on the All-Around Qualifications results of the 2027 World Championships.

If, for any reason as outlined in section **D. “Qualification Pathway”**, this quota place cannot be reallocated at the 2027 World Championships, it will be reallocated by name to the next highest ranked eligible athlete from the host country, based on the All-Around Qualifications results of the:

- 2028 Continental Championships (or the other Continental Qualifying Event approved by the FIG) or, if this is not possible:
- the last Continental Championships edition held with All-Around participation and host country participation.

Reallocation outside the host country

If the host country declines its minimum guaranteed quota place, the unused allocated quota place will be reallocated by name to the next highest ranked eligible athlete, by respecting the provision of a maximum of one quota place per NOC, based on the All-Around Qualifications results of the 2027 World Championships.

If, for any reason as outlined in section **D. “Qualification Pathway”**, this quota place cannot be reallocated at the 2027 World Championships, it will be reallocated by name to the next highest ranked eligible athlete, by respecting the provision of a maximum of one quota place per NOC, based on the All-Around Qualifications results of the last World Championships edition held.

Reallocation of unused universality places

F.3 The unused allocated quota place will be reallocated by name to the next highest ranked eligible universality place.

If the guaranteed universality place is declined, the unused allocated quota place will be reallocated to the next highest ranked eligible athlete, by respecting the provision of a maximum of one quota place per NOC, based on the All-Around Qualifications results of the 2027 World Championships.

If, for any reason as outlined in section **D. “Qualification Pathway”**, this quota place cannot be reallocated at the 2027 World Championships, it will be reallocated by name to the next highest ranked eligible athlete, by respecting the provision of a maximum of one quota place per NOC, based on the All-Around Qualifications results of the last World Championships edition held.
